**MAINE DEPARTMENT OF TRANSPORTATION
DESCRIPTION OF STATE MAINTENANCE BOUNDARY LINES
ESTABLISHED FOR THE URBAN AREA OF**

Skowhegan - Somerset County, Maine

Beginning at a point on North Avenue (State Route 150), 0.78 miles north of Dr. Mann Road; thence, southeasterly to a point on Malbons Mill Road 0.53 mile northeasterly of Mann Road, reference utility pole # 2/45 west side of road; thence, southerly to the junction of Robin Court and Evergreen Drive; thence southerly to easterly right of way of Timberview Drive and Ryan Lane to its end; thence due west to the easterly right of way of Malbons Mill Road and then south to Water Street (U.S. Route 2); thence, southeasterly crossing the Kennebec River to East Front Street (U.S. Route 201) at a point 0.93 miles east of Dartmouth St., reference C.M.P. pole # 59/36 S south side of street; thence, southwesterly to a point on Middle Road (State Route 104) 0.80 miles southwest of Bloomfield Road (inventory Road # 525) reference pole # 22; thence, northwesterly along the southerly right of way of State Route 104 to the intersection of Bloomfield Road; thence southwesterly to the intersection of Main Street and Bigelow Hill Road; thence, northwesterly to a point on West Front Street (US Route 2) 0.38 miles southwest of Poulin Drive,

Thence, northwesterly crossing the Kennebec River to a point on Norridgewock Avenue 0.06 mile west of Mary Street, reference utility pole # 35 north side of street; thence, northerly around the north end of Mary Street to the power line just west of the north end of Coburn Avenue; thence north along the power line to Russell Road 0.27 mile northwesterly of Beech Street; thence, due north to Madison Avenue (US Route 201) at the Skowhegan-Madison Town Line; thence, southeasterly via easterly right-of-way to the junction of East Madison Road, thence, northeasterly to the southeast corner of the town of Madison; thence to the junction of the Transfer Station Road and Steward Hill Road; thence, northeasterly to North Avenue (State Route 150) to a point 0.78 mile from Dr. Mann Road, the point of beginning.

Also a section of Water Street (US Route 2) beginning at a point 0.49 miles west of East River Road to a point on US Route # 2, 0.27 miles east of East River Road, reference pole # 101/8, for a total distance of 0.76 miles.

Note: Bridges, if any, bisected by the State Maintenance Boundary Line are in the rural area.
