1. Describe the type and amount of aquaculture to be conducted during the new lease term:

Net pen cultivation of Atlantic Salmon on a 3 year rotation with periods of fallowing between harvesting and stocking.

2. Describe the amount of aquaculture conducted on the lease site during the previous lease term, including but not limited to seeding, cultivation or harvest of organisms:

Since the lease in 2013, the facility has been stocked on a 3 year rotation cycle, with Atlantic Salmon remaining on site through growth and harvest

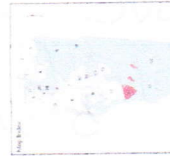
