NEW BUSINESS:

CONSIDERATION OF THE COMMISSIONER'S RECOMMENDED FUNDING LEVELS FOR FY 2020 IN ACCORDANCE WITH TITLE 20-A §15689-C

Pursuant to the provisions of 20-A M.R.S.A., Section §15689-C, the Commissioner, with the approval of the State Board of Education, shall certify to the Governor and

the Bureau of the Budget recommended funding levels for the total cost of funding public education from kindergarten to grade twelve. The funding levels recommended herein were developed based on proposed amendments to the Essential Programs and Service Funding Act, 20-A M.R.S.A. Chapter 606-B.

RECOMMENDATION: The Commissioner of Education recommends that the State Board of Education approve the following motion:

MOVED by Jane Sexton, seconded by Wendy Ault, and unanimously voted those present to ratify the certified funding level for FY 2020 for the total cost of funding public education from kindergarten to grade twelve (including total operating allocation, total debt service allocation, and total adjustments and miscellaneous costs) at \$2,515,886,969, a local contribution amount of \$1,128,145,201 and a state contribution amount of \$1,160,733,317 to be distributed as General Purpose Aid for Local Schools. These amounts shall be distributed per the parameters of the Essential Programs & Services Funding Act, 20-A M.R.S.A. Chapter 606-B, as amended.
