#### **COMMISSION MEETING MINUTES**

19 Union Street ~ Augusta, Maine

September 21, 2015

Commission Chair Arnold Clark called the September 21, 2015 Commission meeting to order at 8:36 a.m. Present were Commissioners Arnold Clark, Sallie Chandler, John Norman, and Deborah Whitworth.

# **AGENDA**

The Housing Foundation, Straw Way Associates and Penquis. 4 in favor | 0 opposed.

Commissioner Chandler moved, seconded by Commissioner Norman, to adopt the Agenda as amended and to accept the Investigator's recommendations in each of the cases on the Consent Agenda. 4 in favor | 0 opposed (see detailed listing on pages 7-8).

#### **MINUTES**

Commissioner Whitworth moved, seconded by Commissioner Norman, to adopt the July 13, 2015 Commission Meeting Minutes. 3 in favor | 0 opposed | 1 abstained. (Chandler abstained)

# **ADMINISTRATION**

Executive Director Amy Sneirson reported that the Commission had formally hired Pamela Soisson into the position of Office Associate II

The Commission is in the midst of interviews for the newly-created Investigator position. Forty applications were received; nine candidates are being interviewed. Once a candidate is identified, the Commission will request permission to hire to the Governor's Office as required by executive order and the Commission will proceed accordingly.

#### **COMPLIANCE**

Commissioners reviewed the compliance report showing two successful conciliations, 12 unsuccessful conciliations, and two (2) conciliations in progress. It was placed on file.

Commissioner Chandler moved, seconded by Commissioner Norman, to accept the conciliation agreement and dismiss E14-0140, Blom v Shaners Family Restaurant pursuant to 5 M.R.S. §4612(3). 4 in favor | 0 opposed.

Commissioner Chandler moved, seconded by Commissioner Norman, to accept the conciliation agreement in El4-0044, Remington v. Lefleurs Restaurant pursuant to 5 M.R.S. §4612(3). 4 in favor | 0 opposed.

#### INVESTIGATION

New Charges: Commission staff opened 62 new cases in July, and 44 new cases in August.

Administrative Dismissals: The Executive Director administratively dismissed 20 cases in July and 22 cases in August.

Pre-determination Settlements: Since June 29, 2015, 30 cases pending at the Commission were resolved resulting in settlements with total monetary relief in excess of \$400,000 for complainants.

# **NEW BUSINESS:**

Executive Director Amy Sneirson requested that litigation matters and new business be taken after the day's cases are heard on the agenda.

At 8:43 AM Chair Clark called for a 5 minute recess.

PA13-0332: Kevin Myshrall (West Bethel) v. Oxford County Sheriff's Department (South Paris). Complainant was not present. Commissioner Chandler moved, seconded by Commissioner Whitworth, to find no reasonable grounds to believe

Oxford County Sheriff's Department discriminated against Kevin Myshrall on the basis of disability. 4 in favor | 0 opposed.

PA13-0563: Hilary Whitmore (Portland) v. Falmouth Pediatric Dentistry (Falmouth). Attorney Tuck Erwin restated the position of the Respondent. Attorney Kristin Aiello restated the position of the Complainant. Investigator Robert Beauchesne restated the facts of the case. Commissioner Chandler moved, seconded by Commissioner Whitworth, to find **reasonable grounds** to believe Falmouth Pediatric Dentistry discriminated against Complainant Hilary Whitmore due to her disability by denying her a reasonable modification. 4 in favor | 0 opposed.

Executive Director Amy Sneirson interrupted the hearing agenda to advise that the Complainant in case PA13-0332 (Kevin Myrshrall v. Oxford County Sheriff's Department) had arrived moments after the Commissioners' vote on the case, and was requesting that the Commission reconsider hearing the case with both parties present. Chair Clark moved, seconded by Commissioner Norman, to set aside the vote on the case and hear argument on PA13-0332: Kevin Myrshrall v. Oxford County Sherirff's Department, 2 in favor | 2 Opposed (Chandler and, Whitworth opposed); the motion failed.

E13-0352: Robert Hack (Greene) v. Lowe's Home Improvement (Mooresville, NC). Attorney Brian Champion restated the position of the Respondent. Attorney Vernie Paradie restated the position of the Complainant. Investigator Angela Tizon restated the facts of the case. Commissioner Whitworth moved, seconded by Commissioner Chandler, to find there are are no reasonable grounds to believe that Respondent Lowe's Home improvement discriminated against Complainant Robert Hack on the basis of age by failing to hire him. 4 in favor | 0 opposed. Commissioner Chandler moved, seconded by Commissioner Norman, to find **Reasonable Grounds** to believe that Respondent discriminated against Complainant on the basis of age by subjecting him to unlawful pre-employment inquiries, and conciliation on this claim should be attempted. 4 in favor | 0 opposed. Commissioner Chandler moved, seconded by Commissioner Norman, to find that there are **Reasonable Grounds** to believe that Respondent Lowe's Home Improvement discriminated against Complainant Robert Hack on the basis of disability by failing to hire him. 4 in favor | 0 opposed.

E13-0564: Marico Wilson (Bangor) v. Team Prior, Inc., Domino's Pizza (Bangor). Attorney Diane Khiel restated the position of the Complainant. Attorney Darby Urey restated the position of the Respondent. Investigator Robert Beauchesne restated the facts of the case. Commissioner Whitworth moved, seconded by Commissioner Norman, to find no reasonable grounds to believe that Complainant Marico M. Wilson was subjected to unlawful race/color, national origin, or ancestry discrimination by Respondent Team Prior, Inc./Domino's Pizza. 4 in favor | 0 opposed.

E13-0608: Jason Brown (Bangor) v. H.E. Murdock d/b/a Day's Jewelers (Waterville). Attorney Stephen Langsdorf restated the position of the Respondent. Attorney Eric Mehnert restated the position of the Complainant. Investigator Robert Beauchesne restated the facts of the case. Commissioner Norman moved, seconded by Commissioner Whitworth, to find that there are **Reasonable Grounds** to believe that Respondent H.E. Murdoch d/b/a Day's Jewelers discriminated against Complainant Jason Brown on the basis of race by subjecting him to a hostile work environment. 3 in favor | 0 opposed | 1 abstained (Chandler abstained). Commissioner Norman moved, seconded by Commissioner Whitworth, to find no reasonable grounds to believe that Respondent discriminated against Complainant Jason Brown on the basis of sex by subjecting him to a hostile work environment. 3 in favor | 0 opposed | 1 abstained (Chandler abstained).

At 11:00 a.m. Chair Clark called for a 5-minute recess.

E13-0647: Stephen Geary (North Yarmouth) v. Turf Products, LLC (Enfield, CT). Respondent was not present. Commissioner Norman moved, seconded by Commissioner Chandler, to find **Reasonable Grounds** to believe that Turf

Products, LLC discriminated against Stephen Geary by terminating his employment on the basis of his age. 4 in favor | 0 opposed.

PA14-0108: Karen Brown (York Beach) v. University of Southern Maine (Portland). Sarah Churchill restated the position of the Complainant. Brenda Haskell restated the position of the Respondent. Investigator Robert Beauchesne restated the facts of the case. Commissioner Whitworth moved, seconded by Commissioner Chandler, to find no reasonable grounds to believe that the University of Southern Maine subjected Karen D. Brown to unlawful discrimination (sexual harassment). 4 in favor | 0 opposed. Commissioner Whitworth moved, seconded by Commissioner Chandler, to find no reasonable grounds to believe that the University of Southern Maine unlawfully retaliated against Karen D. Brown for engaging in protected activity in violation of the MHRA. 4 in favor | 0 opposed. Commissioner Whitworth moved, seconded by Commissioner Chandler, to find there are also No Reasonable Grounds to believe that the University of Southern Maine unlawfully discriminated against Karen D. Brown because of her actual or perceived disability or denied her a reasonable accommodation. 4 in favor | 0 opposed.

At 11:21 Chair Clark moved for a 5-minute recess.

#### **NEW BUSINESS**

**Proposed Rule Changes:** Commission Counsel Barbara Archer Hirsch reviewed the proposed rule changes to Commission Rules Chapter 2 (Procedural Rule) and Chapters 4 and 4-A (Education and Education Procedural Rule). The Commission did not complete its discussion, and agreed to return to it after the afternoon hearing agenda was finished.

At 12:51 Chair Clark called for a 10-minute recess.

Szurgot based upon his sex when it terminated his employment. 4 in favor | 0 opposed.

E14-0286: Romona Carter (Waldoboro) v. Linda Beans Perfect Maine (Rockland). Complainant was not present. Commissioner Chandler moved, seconded by Commissioner Whitworth, to find no reasonable grounds to believe that Respondent Linda Beans Perfect Maine retaliated against Complainant Romona Carter because she engaged in protected activity in violation of the WPA. 4 in favor | 0 opposed.

E14-0297: Marie Grandmaison (Fairfield) v. Local 327 (Augusta). Commissioner Whitworth moved, seconded by Commissioner Norman, to find no reasonable grounds to believe that Respondent Local 327 subjected Complainant Marie Grandmaison to sexual harassment by aiding and abetting harassment in violation of the MHRA. 4 in favor | 0 opposed. Chair Clark, seconded by Commissioner Chandler, moved to find no reasonable grounds to believe that Respondent Local 327 discriminated against Complainant Marie Grandmaison in the terms and conditions of her employment on the basis of sex and/or disability in violation of the MHRA. 4 in favor | 0 opposed. Chair Clark moved, seconded by Commissioner

Norman, to find no reasonable grounds to believe that Respondent Local 327 retaliated against Complainant Marie Grandmaison in violation of the MHRA and WPA because she engaged in protected activity. 4 in favor | 0 opposed.

H15-0199: Melinda Johnson & Rebecca Evans (Searsport) v. Searsport Realty Assoc. Ltd.Part. & Kim Draper (Bangor). Kristin Collins restated the position of the Respondent. Complainant was not present. Investigator Tizón restated the facts of the case. Commissioner Whitworth moved, seconded by Commissioner Clark, to find no reasonable grounds to believe that Searsport Realty Associates c/o Maine Development Associates and Kimberly Draper discriminated against Melinda Johnson and Rebbecca Evans on the basis of sex and sexual orientation by subjecting them to a hostile housing environment. 4 in favor | 0 opposed. Commissioner Norman moved, seconded by Commissioner Whitworth, to find no Reasonable Grounds to believe that Searsport Realty Associates c/o Maine Development Associates and Kimberly Draper discriminated against Melinda Johnson and Rebbecca Evans on the basis of disability. 3 in favor | 1 opposed (Chandler opposed). Commissioner Whitworth moved, seconded by Commissioner Chandler, to find no reasonable grounds to believe that Searsport Realty Associates c/o Maine Development Associates and Kimberly Draper retaliated against Melinda Johnson and Rebbecca Evans for asserting their rights under the MHRA. 4 in favor | 0 opposed.

H15-0200: Brenda Lamb (York) v. Darren Lee, Victoria Lee, Estate of Shirley J. Lee, Harold L. Lee Revocable Trust, and Shirley J. Lee Revocable Trust d/b/a Caincrest Mobile Home Park (York). Attorney Gregory Orso restated the position of the Respondent. Attorney Mark Joyce restated the position of the Complainant. Investigator Angela Tizon restated the facts of the case. Commissioner Whitworth moved, seconded by Commissioner Chandler, to find **Reasonable Grounds** to believe that Respondents discriminated against Complainant on the basis of disability. 4 in favor | 0 opposed. Commissioner Whitworth moved, seconded by Commissioner Chandler, to find no reasonable grounds to believe that Respondents retaliated against Complainant for asserting their rights under the MHRA. 4 in favor | 0 opposed.

At 2:30, the discussion of **Proposed Rule Changes** continued. Commission Counsel Barbara Archer Hirsch continued reviewing the proposed rule changes to Commission Rules Chapter 2 (Procedural Rule) and Chapters 4 and 4-A (Education and Education Procedural Rule). The Commission had many questions regarding the Chapter 4 proposed changes, and Commission Counsel suggested that she make further revisions to the Chapter 4 proposal and bring the Proposed Rule Changes to the Commission for its October 26 meeting. The Commission agreed.
