1. This is your renewal application for the vehicle described on front. You may take this form to your local Recreational Vehicle Registration Agent or return to the address below with the appropriate fee to re-register this vehicle. (Antique Snow only done in Augusta office)
2. Boat excise tax must be paid by a resident to the tax collector of his town before renewing a boat registration. A nonresident, prior to registering a motor boat which is located in Maine more than 75 days during a calendar year, must pay an excise tax to the Maine town where the boat is principally moored, docked or located. If the boat is exempt from tax, a tax exemption form must be completed by the owner and submitted with registration application and registration fee.
3. No excise tax is due on a snowmobile or an all terrain vehicle.
4. **Registration fees** - make checks payable to Treasurer State of Maine. (fee includes \$1.00 agent fee)

    - a) 0-10 HSP Motor - \$26.00 with milfoil (\$16.00 without milfoil)
    - b) 11-50 HSP Motor - \$31.00 with milfoil (\$21.00 without milfoil)
    - c) 51 - 115 HSP Motor - \$37.00 with milfoil (\$27.00 without milfoil)
    - d) 116 & Higher Motor - \$45.00 with milfoil (\$35.00 without milfoil)
    - e) Personal Watercraft - \$45.00 with milfoil (\$35.00 without milfoil)
  - Resident Snowmobile** - \$46.00 **Nonresident Snowmobile - Season** \$100.00 **3-Day** \$50.00 **10-Day** \$76.00
  - Antique Snowmobile** - \$34.00 Non resident not eligible for this registration. Machine must be more than 25 years old, maintained in original or restored condition and owned by residents of the State of Maine. Machine can only be operated for the purpose of traveling to and returning from and participating in an exhibition, parade, or other event or for occasional personal use. An antique snowmobile registration is valid until the ownership of that machine changes. These registrations cannot be transferred to another person. The new owner is then responsible to register the machine.
  - Antique Snowmobile registrations can only be done in the IFW Augusta office.**
