TO: All Agency Department Heads, Human Resource Representatives

SUBJECT: REVISED VALUE OF BENEFITS WHEN PUBLISHING SALARIES

Maine law requires that a statement of the dollar value of the fringe benefits package provided by the state must be placed in all advertisements that indicate the salary of a position. This includes all advertisements or other announcements that agencies may develop to fill "direct hire" vacancies. This memorandum reflects revised health insurance, dental insurance and retirement rates that are effective July 1, 2007.

All advertisements for positions that will be filled on or after July 1, 2007 must reflect the health/dental insurance and retirement rates listed below. All previous human resource memoranda pertaining to the value of benefits are superseded effective July 1, 2007.
