 - Clarence Young, James W. Sewall Company, led the discussion for the Authority's review of the final version of the plan for adoption and implementation. The plan will be the Authority's roadmap of expectations for what we are doing and where we should be involved. It will help us help other agencies, states, and organizations; as we have had numerous contacts regarding strategic plans, how we operate, and our successes.
