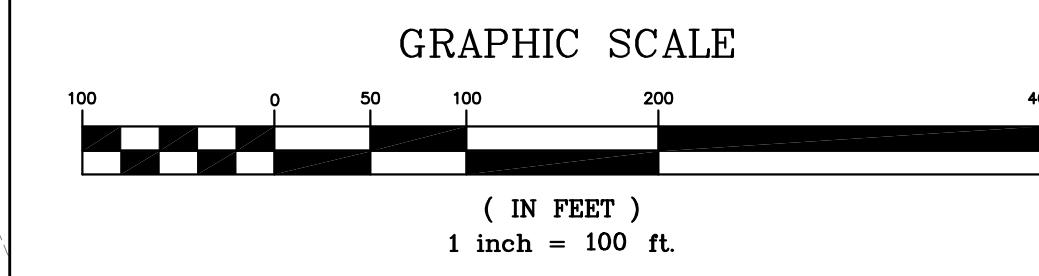




**ALIGNMENT "T8-9" - CRANE PATH**

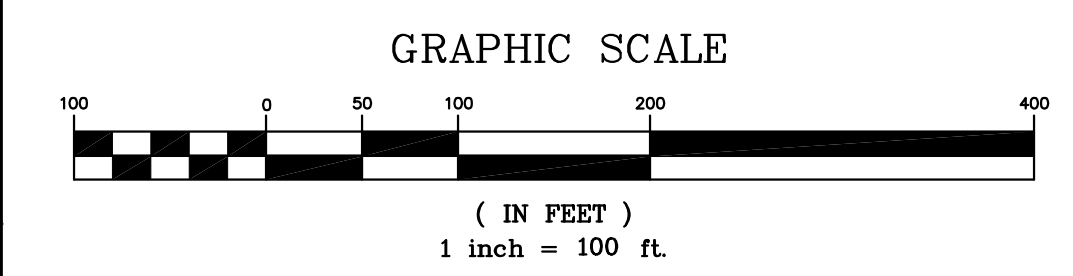




**ALIGNMENT "NORTH STRING" - CRANE PATH**
