

The Maine Department of Agriculture, Conservation and Forestry is partnering with the USDA Natural Resources Conservation Service (NRCS) to inform fruit and vegetable growers of opportunities available through the Environmental Quality Incentives Program.

# What is the Environmental Quality Incentives Program?

NRCS offers the Environmental Quality Incentives Program (EQIP) as a voluntary conservation program that supports production agriculture and environmental quality as compatible goals. Through EQIP, growers may receive financial and technical assistance in adopting more ecologically beneficial pest management practices.

# **Eligibility**

Any agricultural producer engaged in livestock or crop production on eligible land may apply for EQIP. Eligible land includes cropland, rangeland, pasture, and private non-industrial forestland. In order to be eligible to sign up for EQIP, the applicant must be determined to be an eligible producer by NRCS.

The land offered for EQIP must also be determined eligible by NRCS. Eligible land is land that has a resource concern identified by a certified conservation planner that can be addressed through application of the conservation practices eligible for the sign up period.

# **How to Apply**

# Contact your local Farm Service Agency to determine your eligibility.

If you are a new USDA program applicant, please contact your local Farm Service Agency office, located at the USDA Service Center, for information on eligibility requirements. If you have been a USDA program participant in the past, please contact your local USDA Service Center office to review and update information.

## ✓ Apply for financial asistance.

Contact your local NRCS field office, located at the USDA Service Center, and apply for financial assistance. Application for EQIP financial assistance contracts may be submitted at any time. There are typically one or two application evaluation and ranking periods each year. The number of applications funded in each evaluation and ranking period is limited by availability of funds.

Financial assistance is NOT a grant. You initiate and pay for all conservation treatments specified in the NRCS contract. Once those activities are certified as complete and as meeting NRCS standards and specifications, NRCS will reimburse you based on payment rates established in the contract.

The EQIP financial assistance agreement lasts from one to ten years from the date the contract is signed. Contract length is based on the practice implementation schedule. Under the agreement, you agree to maintain the contracted practices.

# ✓ Work with your NRCS field office to develop a conservation plan.

To be considered for funding during an evaluation and ranking period, your application must be supported by a

completed conservation plan that reflects your decision to address identified natural resource issues by implementing

eligible EQIP practices. Contact your NRCS field office to sign up for assistance in completing a conservation plan. This assistance is offered at no cost to you.



A conservation plan assesses resource concerns (soil, water, air, plants, and animals) and identifies conservation practices that are eligible for EQIP or similar programs. The plan describes your goals and objectives that address those concerns and lists ways that will promote stewardship, yet maintain farm productivity.

Your conservation plan may include integrated pest management activities such as insect trapping, scouting, record keeping, trap cropping, row covers, or biological control under the Pest Management Practice Standard. A conservation plan may also include other NRCS practices.

To get started, you will need copies of:

- Pest and nutrient management records.
- A list of areas where you have conservation concerns.
- A list of crops and rotation schedules, if applicable.

# ✓ Submit your application.

Once you have completed the conservation planning process with NRCS field staff, submit your application to NRCS. It will be ranked with other applications in Maine based on NRCS Field Office Technical Guide resource concerns and quality criteria. Higher priority will be given to applications that use cost-effective conservation practices; address national, state, and local priority resource concerns; and provide long-lasting, environmental benefits.

## **Contract Obligation**

Applications chosen for funding will receive a financial obligation based on current fiscal year payment rates developed for eligible EQIP practices. Under the contract, participants agree to install or implement contracted practices according to NRCS Standards and Specifications and to maintain the practices for a specified life-span period. Participants also agree to allow NRCS employees access for providing technical assistance, certifying practice completion, and performing annual contract compliance reviews.
