POLICY ON THE SALE OF RESTRICTED/LIMITED USE PESTICIDES TO UNLICENSED CORPORATE FARM EMPLOYEES OR TO A PUBLIC OR PRIVATE LENDERS

At its July 26, 2002 meeting, the Maine Board of Pesticides Control voted to amend its policy covering the sale of limited and restricted use pesticides to unlicensed purchasers as described below:

Under Maine law, the purchaser of a RUP must be a licensed applicator. Furthermore the purchaser is deemed to be the person who pays for the product. Prior to May 2002, the Board provided a purchase verification form that could be used in the following three situations:

- 1. The owner is not licensed but has a licensed employee.
- 2. There is a corporate farm with a licensed employee.
- 3. There is a licensed owner but the bills are paid by governmental or private lenders.

At its May 3, 2002 meeting, the Board voted to eliminate by the end of the year the first situation where the owner is not licensed but has a licensed employee.

The members took this action after considering the use of the old verification form for dairy farmers who hired a commercial applicator to apply the restricted use corn herbicides. An excerpt from the meeting is produced below:

6. Review of the Board's Verification Form for the Purchase of Restricted Use Pesticides when the Farm Owner of Person Paying for the Pesticides is not Licensed

Recently, the Board has been asked to address a situation where dairy farmers in Central Maine are not licensed but hire commercial applicator firms to apply their restricted use pesticides. The growers would prefer that Agway bill them on a credit basis rather than having to pay the commercial applicator for the cost of the chemicals and service at the time of application. The staff believes the simplest solution to this problem is for the growers to obtain a private applicator license.

Presentation By: Gary D. Fish Certification & Licensing Specialist

Action Needed: Discussion and determination if any change in the current policy is warranted.

Batteese called the members attention to a revised verification form included in their packets. He explained that once the form was completed by all parties the dealer could deliver the

material to the licensed commercial applicator and bill the grower. The applicator would not be allowed to leave any unused material on the grower's farm but would have to return it to the dealer. Both Lauchlin Titus of Agway and Milton Sinclair of Paris Farmers Union supported the use of the new verification farm and indicated it would only be needed for a small number of growers. Holyoke observed that obtaining a license should not be a burden and attendance at recertification meetings would be helpful to the growers over the long term.

Crane/Humphreys: Motion made and seconded to authorize the use of the revised verification form for the remainder of 2002.

In Favor: Unanimous

At the July 26, 2002 meeting, the staff provided the Board an update on this issue as follows:

- 9.c. Update on the Restricted Use Pesticide Purchase Verification Forms R. Batteese
- Batteese explained he had included a copy of the letters to remind the Board that the verification forms were for one year's use only. There was consensus that this was true and the growers should get licensed before next year.



PRIVATE APPLICATOR RESTRICTED/LIMITED USE PESTICIDE PURCHASE VERIFICATION

This form is only valid after approval by an authorized representative of the Board.

It should be used when the person who purchases (pays for) a restricted or limited use pesticide does not hold a current private applicator license and is not engaged in the daily operation of the farm. This form may be used when a corporate employee or a public or private lender pays the bills. It may not be used by a farm owner who is not licensed. All persons involved must understand that the licensed private applicator shown below must be a regular employee of the specified farm and must provide direct, on-site supervision of each and every application. This licensee is responsible for all aspects of pesticide use including purchase, transportation, storage, application and disposal and is accountable for any mishaps or violations. Furthermore, this person must assure any pesticides purchased for the specified farm are applied only on property owned or leased by that farm.
