

Hi Mike,

Thank you for the clarification. I wasn't intending to narrow your request.

The easiest answer to your timeframe question is to distinguish between the our licensing file and everything else. Our licensing files will typically capture much of what you are looking for including all photos and important correspondence, the application and any changes or revisions to the project. That material is relatively simple to compile, convert to electronic form for review, and provide access. I'd estimate, about a week for that.

Materials that requires additional compiling will take longer. We understand the urgency of your request, given the limited appeal window, and will expedite our response in any way possible, including providing records on a rolling basis as they become available. I don't anticipate material such as notes or additional emails to take much more time; however, usually requests for "all records" or "all communications" take anywhere from 1 - 6 months to ensure the response is comprehensive and doesn't miss anything. This project would certainly be on the lower end of that time frame. I'm working with staff currently and am hoping we can reduce that estimate closer to 2 weeks.
