FINDINGS OF FACT

After review of the file and related materials submitted with regard to the above noted application, pursuant to Title 38, M.R.S.A., Section 590 and 06-096 CMR 115 (as amended), the Maine Department of Environmental Protection (the Department) finds the following facts:

I. Registration

Lepage Bakeries Park Street LLC has requested the transfer of Air Emission License A-968-71-B-N/A from Lepage Bakeries, Inc. to Lepage Bakeries Park Street LLC through a letter to the Bureau of Air Quality dated January 29, 2013. Air Emission License A-968-71-B-N/A was issued to Lepage Bakeries, Inc. on January 22, 2013. The facility is a commercial bakery.

II. Transfer Requirements

A. Title, Right, or Interest

In their application, Lepage Bakeries Park Street LLC submitted copies of property deeds transferring ownership of the facility to Lepage Bakeries Park Street LLC. The parties have provided sufficient evidence of title, right, or interest in the facility to allow the transfer of the facility's licenses.

B. Financial Capacity and Intent

Lepage Bakeries Park Street LLC states that they possess the financial capacity to operate the facility in compliance with its air emission license.

C. Technical Capacity and Intent

Lepage Bakeries Park Street LLC acquisition of the facility is not expected to result in any significant change in the employees that currently operate the equipment, facilities, and conduct other activities. The facility's regulatory history with the Department demonstrates that the environmental personnel are competent in air pollution control. The information submitted in the application

provides sufficient evidence that Lepage Bakeries Park Street LLC has the technical capacity and intent to comply with their air emission license.
