FINDINGS OF FACT

After review of the file and related materials submitted with regard to the above noted application, pursuant to Title 38, Maine Revised Statutes (M.R.S.) § 590 and 06-096 Code of Maine Rules (C.M.R.) ch. 115, the Maine Department of Environmental Protection (the Department) finds the following facts:

I. Registration

SHM Great Island, LLC has requested the transfer of Air Emission License A-1079-71-A-N from Delmar Marine, LLC d/b/a Great Island Boatyard to SHM Great Island, LLC through a letter to the Department dated 6/17/20. Air Emission License A-1079-71-A-N was issued to Delmar Marine, LLC on 8/23/13. The license was subsequently amended on 9/14/18 with amendment A-1079-71-B-M. The facility is a boat repair facility.

All rules, regulations, or statutes referenced in this air emission license refer to the amended version in effect as of the issued date of this license.

II. Transfer Requirements

A. Title, Right, or Interest

In their application, SHM Great Island, LLC submitted copies of property deeds transferring ownership of the facility to SHM Great Island, LLC. The parties have provided sufficient evidence of title, right, or interest in the facility to allow the transfer of the facility's licenses.

B. Technical Capacity and Intent

SHM Great Island, LLC acquisition of the facility is not expected to result in any significant change in the employees that currently operate the equipment and facilities. The facility's regulatory history with the Department demonstrates that the environmental personnel are competent in air pollution control. The information submitted in the application provides sufficient evidence that SHM Great Island, LLC has the technical capacity and intent to comply with their air emission license.

Based on the above, the Department concludes that the applicant for the air emission license transfer has the capacity to satisfy all applicable statutory criteria and hereby APPROVES the transfer of Air Emission License A-1079-71-A-N, from Delmar Marine, LLC to SHM Great Island, LLC, subject to all conditions attached to it.

<u>Severability</u>. The invalidity or unenforceability of any provision of this License Transfer or part thereof shall not affect the remainder of the provision or any other provisions. This License Transfer shall be construed and enforced in all respects as if such invalid or unenforceable provision or part thereof had been omitted.
