Pursuant to the State of Maine's Taxation and Environmental Laws, 36 M.R.S.A. §§ 656 and 1730, and 38 M.R.S.A. §§ 413 et seq., 480 et seq., 581 et seq., and 1301 et seq.; rules promulgated pursuant to these laws; and the Department of Environmental Protection's (Maine DEP) *Rules Concerning the Processing of Applications* (April 1, 2003), 06-096 CMR 2.21, the application for license transfer of Katahdin Paper Company LLC (KPC) has been considered with its supportive data, agency review comments, and other related materials on file.

**1. FACTUAL FINDINGS.** The following paragraphs describe certain information on record regarding KPC's license transfer application.

**A. Procedural History.** An application was submitted to Maine DEP on April 2, 2003, seeking the transfer to KPC of all active licenses, permits, approvals, permits-by-rule, registrations, variances, certifications and amendments thereto, and condition compliance orders issued in the name of, or transferred to, Great Northern Paper, Inc. (GNP), and applications pending, regarding the Millinocket and East Millinocket facilities described in Section 1(C) of this Order. A listing of permits and applications that are the subject of this Maine DEP Order is set forth in Appendix A.

**B. KPC's Asset Purchase.** On January 6, 2003, GNP filed a petition to reorganize its debt pursuant to Chapter 11 of the United States Bankruptcy Code. On April 3, 2003, the United States Bankruptcy Court for the District of Maine approved the sale of substantially all GNP's assets to Brascan Corporation or its designee. KPC is a wholly owned subsidiary of Brascan Financial Corporation, which is a wholly owned subsidiary of Brascan Corporation. KPC is the entity to which all the purchased assets will be transferred upon closing of the purchase.

**C. Operations.** The Millinocket and East Millinocket facilities are integrated pulp and paper mills located adjacent to the Penobscot River. The pulp mills produce approximately 1,180 tons per day of mechanical pulp using groundwood and thermomechanical pulping techniques. This pulp is supplemented by purchased kraft and CTMP pulp. Most recent operations found the mills producing approximately 600,000 tons of paper on an annual basis.

Licensed air pollutant emissions originating at the Mills primarily result from six (6) oil-fired boilers, one (1) multi-fuel boiler burning wood, bark, paper cores and other paper related waste products, primary clarifier sludge from the Millinocket and East Millinocket mills, recycle plant sludge, railroad ties and telephone poles, and one (1) MgO boiler operated for the recovery of chemicals. These boilers are used to generate steam and

electricity for the mills.

Licensed wastewater discharges originating at the Mills result primarily from pulp and papermaking processes. The facilities use an on-site activated sludge wastewater treatment plant located on the East Millinocket site, with primary clarifiers, aeration basins, and secondary clarifiers, to minimize direct pollutant discharges to the river.

Solid wastes generated by the Mills are disposed of adjacent to the East Millinocket facility in a 70 acre landfill that consists of 17 disposal areas, or cells. This facility, collectively known as the Dolby Landfills, was proposed in KPC's application for future ownership and control by KPC, and operation by Fraser Papers, Inc.

**D. Transfer Requirements.** The following four (4) paragraphs describe in detail the facts specifically considered in making a transfer decision.

**(1) Title, Right, or Interest.** With its application, KPC submitted a copy of an Asset Purchase Agreement between Brascan Corporation and GNP dated March 31, 2003. This agreement was approved by the Bankruptcy Court on April 3, 2003. Upon closing, all the assets subject to that agreement and Court approval will be transferred to KPC.

**(2) Financial Capacity and Intent.** KPC submitted its Pro Forma Projections, Brascan Financial's 2002 Financial Report, Brascan's 2002 Interim Report to Shareholders, Nexfor's 2002 Interim Financial Statements, and other related financial information in support of its financial capacity and intent to operate the facilities. This information shows that KPC projects approximately \$66 million in revenue for 2003, \$133 million in 2004 and \$267 million in 2005. Brascan Financial has over \$4.3 billion (CDN) in assets. Brascan has over \$22 billion (CDN) in assets. Nexfor has over \$2 billion (USD) in assets. The Millinocket and East Millinocket mills will have access to these resources as a wholly owned subsidiary, in addition to cash flow generated by the facilities.

To satisfy closure and post-closure care financing obligations, as required by Maine's Solid Waste Management rules, *General Provisions*, 06-096 CMR 400.11, KPC submitted a letter dated April 14, 2003, committing to establish a reserve account in accord with IRC and DEP requirements, 06-096 CMR 400.11(A)(4)(e), for estimated closure and post-closure care costs.

**(3) Technical Capacity and Intent.** KPC's purchase of the Millinocket and East Millinocket facilities will result in operation of the mills by Fraser Papers Inc. under a management agreement. This arrangement has day-to-day management conducted by Fraser, a company having a regulatory history with Maine DEP that demonstrates the environmental personnel are competent in air pollution control, wastewater control, solid waste handling and disposal, and hazardous waste management.

**E. Solid Waste Facility Disclosure.** In accordance with Maine's Solid Waste Management Rules, *General Provisions*, 06-096 CMR 400.12, KPC provided a disclosure statement regarding criminal and civil records for KPC, Brascan Financial, and Fraser

Papers Inc.; information on Brascan and Nexfor was not provided. KPC requires a variance to rule provisions, 06-096 CMR 400.12 A(2); KPC has provided, with agreement from Maine DEP staff, only the municipality in which the persons required to disclose reside. While one completed and one ongoing enforcement resolution with Fraser Papers Inc. exist within the last five years, its response has demonstrated reasonable efforts to clean up or mitigate any environmental damage caused by the violations. Otherwise, no violations were reported.

2. **CONCLUSIONS.** The Findings of Fact in Section 1 of this Order lead Maine DEP to establish the following conclusions.

**A. Title, Right or Interest.** The purchase described in Paragraph 1(D) of this Order, including any subsequent alterations of the APA by the Bankruptcy Court, provides KPC with sufficient title, right, or interest in the subject property to allow the transfer of GNP's licenses, permits, approvals, permits-by-rule, registrations, variances, certifications and amendments thereto, condition compliance orders, and applications pending. Satisfaction of the title, right, or interest requirements post-closing is contingent upon satisfaction of Condition 2 in this Order.

**B. Financial Capacity and Intent.** Projected revenue and the significant assets of its parent company and operating contractor allow Maine DEP to conclude that the newly formed KPC has demonstrated sufficient financial capacity and intent to assure compliance with all Maine DEP licenses, permits, approvals, permits-by-rule, registrations, variances, certifications and amendments thereto, condition compliance orders, and applications pending as well as any statutory and regulatory criteria applicable to the Millinocket and East Millinocket facility operations, including the landfill.

KPC's financial assurance mechanisms proposed for the Dolby Landfills provide financial assurance sufficient to ensure that funds are available to pay the anticipated costs of compliance with all facility closure and post-closure maintenance and monitoring. Satisfaction of this financial assurance requirement post-closing is contingent upon satisfaction of Condition 3 in this Order.

**C. Technical Capacity and Intent.** Information submitted in the application provides sufficient evidence that KPC will have the technical capacity and intent to comply with all Maine DEP licenses, permits, approvals, permits-by-rule, registrations, variances, certifications and amendments thereto, condition compliance orders, and applications pending as well as any statutory and regulatory criteria applicable to the Millinocket and East Millinocket Mill operations, including the landfill.

**D. Solid Waste Facility Disclosures.** Brascan Financial's, Fraser's, and KPC's civil and criminal records show satisfactory ability to comply with the licenses, permits, approvals, permits-by-rule, registrations, variances, certifications and amendments thereto, condition compliance orders, and applications pending as well as any statutory and regulatory criteria applicable to the Millinocket and East Millinocket mill operations, including the landfill. KPC has presented clear and convincing evidence that the limited information supplied on the persons required to disclose under 06-096 CMR 400.12 A(2) complies with the intent of State law and 06-096 CMR 400.12.

THEREFORE the Maine DEP APPROVES the above-noted application of KPC subject to the following CONDITIONS and all applicable standards and regulations:

1. It shall abide by the terms and conditions of all licenses associated with the facilities described in the Findings of Fact above, specifically including those listed in Appendix A.
2. The force, effect, and validity of this Order is contingent upon closing of the purchase described in Paragraph 1(D) of this Order. Within 30 days of the effective date of this Order, KPC shall submit to Maine DEP written certification confirming that the closing occurred consistent with the purchase described in Paragraph 1(D) of this Order, including any subsequent alterations of the APA by the Bankruptcy Court.
3. Within 30 days of the effective date of this Order, KPC shall submit to the Maine DEP for its review and approval information sufficient to confirm the establishment of a Reserve Account in accord with Maine's Solid Waste Management Rules, *General Provisions*, 06-096 CMR 400.11.


