**NOTES:** **Authority for Tank Installers.** An underground oil storage tank installer may install, inspect or remove any type of underground oil storage tank, with the exception of field-constructed storage or impressed-current cathodically-protected tanks.

**Underground Storage Tank Inspectors (INSP):** Permits the tank inspector to conduct annual inspections of underground storage facilities. A third party cathodic protection tester certificate is also required to conduct the cathodic protection tester portion of the annual inspection. Certification by the manufacturers of leak detection equipment is required to annually inspect specific brands and models of equipment.
