certificates **as well as** any past and current refresher training certificates needed to demonstrate continuity of training.

Inspector and Risk Assessor applicants shall also submit documentation demonstrating successful completion of radiation safety training appropriate to the use of an x-ray fluorescent lead-in-paint analyzer (XRF).

B. Renewal Application:

Renewal applicants must submit copies of applicable annual 8-hour refresher training certificates. Initial course certificates are **not** required for renewal applicants.

4. Education & Experience Requirements:

Applicants shall submit documentation to demonstrate they have met the following applicable education and experience requirements.

Worker:

- Education and experience: No minimum requirements.

Project Supervisor:

- Education: High school diploma or G.E.D.
- Experience: One year as a lead abatement worker or two years experience in building trades, asbestos abatement, environmental technician, or related field. (Relevancy of a related field shall be determined by the Department.)

Design Consultant:

- Education and experience: Bachelors degree in engineering, architecture or a related profession plus one year experience in building construction and design or a related field; or high school diploma or G.E.D. plus four years of experience in building construction and design or a related field.

Sampling Technician

- Education and experience: High school diploma or G.E.D.

Inspector:

- Education and experience: High school diploma or G.E.D.

Risk Assessor:

- Education and experience: Certified industrial hygienist, professional engineer, registered architect, or related scientific field; plus one year as a certified lead inspector including a minimum of 20 lead inspections; or Bachelors degree in related field or high school diploma/G.E.D. with a combination of education and experience equivalent to the educational requirements listed above. In lieu of the experience requirements, an applicant may pass a field assessment by the Department of her or his ability to appropriately implement risk assessment procedures. If utilizing this option for certification requirements, please note the date of the field assessment and the DEP staff performing the field assessment.

5. Application and Certification Fees:

The application must include a non-refundable cashiers, certified or company check, made payable to the **Maine Environmental Protection Fund**. The amount shall be:
