3. DWP GENERAL UPDATES (STAFFING, DWSRF, ETC)

Mike stated that the DWP currently has three vacancies. The DWP has advertised for the Education and Outreach Coordinator. Holly Ireland with our Rules group has taken another position within the Maine CDC. We are currently waiting to get permission to fill that position. Ami Stillings has been hired as the new Rules Coordinator Supervisor. The DWP is waiting to get permission to hire an ES3 position to fill Ami Stillings old position in Data Management.

Mike discussed LD153- Lead testing in all schools, including schools on municipal water systems, would be managed the DWP.

5. PFAS/CYANOTOXINS SAMPLING PROJECT UPDATE

Mike discussed ongoing PFAS testing projects, and future testing. There was discussion about the PFAS task force set up by the Governor. Mike Stated that the task force is looking to release a report by the end of the year. Mike and the DWC discussed the possibility of issuing status updates to PFAS issues.

Mike gave an update on plans to revamp the Maine CDC website. Mike stated that the DWP can't just revamp our site as it's part of the CDC Website. Kathy thought to invite The DHHS Commissioner or Governor to tour The Bangor Water District. Mike was going to pass the invite on to The DHHS Commissioner and Governors office.

Brian mentioned that the Winterport Water Districts new Water tank is almost ready to go on line.
