## Call to Order:

<u>Allegation</u>: Sediment entering the well and fouling filters and other equipment in their home.

Well Drilling Company: Carmel Well Drilling Company

Responsible Master Driller: Karl Rudnicki

### Commission action:

An appeal hearing was conducted on the afternoon of March 14, 2011. The hearing officer presented to the Commission a draft response based on the testimony that was heard and evidence presented.

The draft response affirmed the Commission's original findings and required corrective actions. After discussion, minor changes and corrections to the draft were made.

Don Robbins moved that the Commission accept the hearing officer's recommended response which affirmed the Commission's original findings and required corrective actions. Dwight Doughty 2nd the motion. Commission approved. Braley and Goodwin did not participate.

Karl Rudnicki of Carmel Well Drilling was informed of his option to appeal to Superior Court and that absent a judicial appeal he had 60 days to complete the corrective action from the date of receiving the order.

# Complaint received from: Christopher Baudo

Allegation: Improper installation of water lines.

Well Drilling Company: Skilling & Sons, Inc.

Responsible Pump Installer: Scott Wilkins

## Findings of Fact:

Brent Lawson a state plumbing inspector testified that in his opinion there was no violation of the internal plumbing code.

Skillings & Sons did act in good faith to install the lines in the trench and did leave the site on the first occasion and have to come back at their own expense.

### Commission action:

Dwight Doughty motions that after consideration of all the facts and Brent Lawson's testimony, that there is no violation or improper installation of water lines. Don Robbins  $2^{nd}$  the motion. Commission approved.

## Geo-Thermal:

David Braley motions to adopt the Geothermal licensing rules. Dwight Doughty  $2^{nd}$  the motion. Commission approved.

Discussion was over geothermal construction rules. Copper pipes not allowed based on IGSHPA standards. Piping must be certified by IGSHPA or it is not allowed.

Pump Installers may get the open loop endorsements, but not under the grandfathering. They will need to take the open loop exam in order to receive the endorsement. Pump installers do not need a closed loop endorsement as only a well driller may install loops.
