#### Specialty Well Applications done "in House"

Robert Herlihy- Susan Smith, Hansen's Well Drilling Inc. Proposed well to be located no closer than 60 feet from the onsite leach field and 60 feet from the onsite septic tank. Seal just above freshwater fracture.

#### Exams requested:

Don Robbins makes a motion to accept Thomas Mason's Master Well Drilling examination application and sit for the exam. Ike Goodwin  $2^{nd}$  the motion. Commission approves. Passed.

#### Examinations Passed:

#### New Business:

The Commission inadvertently failed to notify Danny Marquis of Marquis Well Drilling and the complainant Michael Cyr, concerning

the finding of no violation regarding Mr. Cyr's complaint. The notification letter will be mailed immediately.

The Commission discussed geothermal licensing requirements and that everyone that is on-site working at a geo-thermal project must be licensed as at least an apprentice. Also, at least one journeyman or master must be present on-site. Reminder letters will be going out to all those that are currently licensed under geo-thermal only.

There have been some problems with the software used to renew well drillers. As soon as the problem has been fixed, licenses will be going out to all well drillers that have sent in a renewal with payment. If there are any concerns from a consumer, etc., they can call the commission clerk for verification that the driller does have a current license.

### Geo-Thermal:

The geothermal licensing rules will be submitted to the Executive Director of the Legislative Council as required by the Administrative Procedures Act. The geothermal construction standards rules will be delayed while instructions concerning how to proceed are developed by the governor's office. All rulemaking has been suspended by the governor until further notice.
