Dear Mr. Papczynski:

The Division of Environmental Health has completed a review of a registration application for your company's product. This information was submitted pursuant to Section 1802 of the Maine State Plumbing Code, Subsurface Wastewater Disposal Rules (Rules), for code registration, for use in Maine.

The Aero-Tech Models consist of a fiberglass tank with integral aeration-mixing, and settling areas. The device is designed to treat 500 to 1,500 gallons of wastewater per day, according to specific model. According to the information you provided, the Aero-Tech Model AT-500, AT-600, AT-750, AT-1000, and AT-1500 have been certified by the National Sanitation Foundation (NSF) pursuant to ANSI/NSF Standard 40 for residential wastewater treatment systems.

On the basis of the information submitted, the Division has determined that the Aero-Tech Model AT-500, AT-600, AT-750, AT-1000, and AT-1500 are acceptable for use in the State of Maine, provided that they are installed, operated, and maintained in conformance with the manufacturer's directions.

Because installation and owner maintenance has a significant effect on the working order of onsite sewage disposal systems, including their components, the Division makes no representation or guarantee as to the efficiency and/or operation of Aero-Tech products. Further, registration of these products for use in the State of Maine does not represent Division preference or recommendation for them over similar or competing products.
