This year stores located in Androscoggin, Franklin, Knox, Lincoln, Oxford, Penobscot, Piscataquis, Sagadahoc, Waldo Counties must attend WIC mandatory training. WIC vendors are required to send at least one representative to one of the following training sessions during 2016. Stores that do not attend a training session will not be eligible for reauthorization and will not be able to accept WIC checks after November 30, 2016. **Register early– Space is limited by site.**

This training will highlight key instruction that will assist stores to achieve successful WIC transactions. Vendors will receive their reauthorization applications. Approximate length: *2 hours*. Registration confirmation will be provided.
