Sponsor and Delivery Location Sheets for 2025

In order to open up SY 2025 annual order <u>ALL</u> districts must have both of their sponsor applications and delivery location sheets in <u>approved</u> status. **This is a Two-step process.** Please follow these step-by-step instructions.

Once all the sheets are in approved status follow the steps below:

Select: Applications tab. This is a Two-step process.

 Select Sponsor Application sheets, select edit, make all necessary updates, enter in emails, check off #45, submit.
 Status will go from Pending Submission to Approved status.

2. Select **Delivery location information sheets**, select edit, update all information. The next **step is crucial**. **Under storage capabilities**, make sure **dry**, **refrigerated**, **and frozen boxes are checked off**, this is where your USDA foods get delivered. If you only have one delivery application, then all 3 must be checked off. If you have several delivery locations, you may have dry and frozen items going to one school and refrigerated going to another school. Make sure they are checked off appropriately for your deliveries.

Site Eligibility

Below are resources to use to establish site eligibility

ED 534 - The free and reduced price data for SY 2024. If the school in the site's attendance area is over 50% free or reduced, the site could be open eligible. <u>Free and Reduced Data.</u>

Area Eligibility Mapper - The area eligibility mapper is another resource. Type in the site's address and if it is in a pink area, it is considered area eligible as an open site. If the census block is blue but adjacent to a pink tract, you can work with DOE to see if averaging is an option. The link to the <u>mapper</u>

5 Year Eligibility - As a reminder, there is a 5 year eligibility period for open sites. Work with Maine DOE Child Nutrition for more information. We always try to establish eligibility each year to extend the 5 year period.

Closed enrolled or camp sites – These sites are established based on the free/reduced status of participants enrolled in the program. In some cases, area eligibility can be used to create closed enrolled sites.

New conditional non-congregate sites in rural areas— These sites offer noncongregate meals in rural areas that are not area eligible. Reimbursement is only received for children who meet free/reduced income guidelines.

Non-Congregate Meals in Rural Areas

Are you interested in operating SFSP in rural areas? Did you know that you may be eligible to provide meals to go? USDA has expanded their <u>rural eligibility map</u> and created a permanent rural, non-congregate meal program to ensure children who don't have access to congregate services, such as summer school or camp programming, receive meals. 
Community Eligibility Provision

Community Eligibility Provision (CEP)

USDA has changed the qualification to participate in CEP. It has gone from 40% to 25%. We will be offering three webinar opportunities for Districts to learn: *How to Participate in CEP *What you need to do for your District or group of schools within the District to participate. **CEP** removes the need for collecting applications and completing the Verification process for 4 years. 
