

INDEPENDENT EXPENDITURES OVER \$250 MADE BEFORE FEBRUARY 1, 2012

- Independent expenditures made before February 1, 2012 that total more than \$250 per candidate must be reported within 2 calendar days of making the expenditure.
- Each time the total amount spent per candidate exceeds \$250 before February 1, 2012, an independent expenditure must be filed within 2 calendar days.

All other independent expenditure reports must be filed according to the schedule below for:

- The reports are due by 5:00 p.m. on the filing deadline.
