Correctional/Judicial Impact: Establishes new Class D crimes and decreases the number of Class E crimes and civil violations. Impact will be primarily to the county jail system. The average costs to the county for a Class D crime is \$6,795 based on an average length of stay of 62 days at \$109.60 per day. There is expected to be an insignificant impact on the caseload of the Judicial Department.
