



Statement of Fact

This financial order will allot a portion of the unencumbered balance forward for the purpose of funding recruitment and retention stipends as authorized by Public Law 2015, Chapter 16. The fiscal year 2014-15 stipends were not disbursed before the end of the 2014-15 fiscal year and the allotment granted by Statewide Financial Order 002895 F5 is now needed in fiscal year 2015-16 to meet these obligations. Failure to allot these funds will result in the inability to meet remaining 2015-16 fiscal year payroll obligations.


