

Mapbook User Guide

Roads in this document are designated by the federal or state route numbers, and or the road name. The name will be in parenthesis after the route number. Not all road segments have names. Numbered routes (federal and or state) can overlap. You may see multiple numbers on a single road. The maps are labeled

accordingly. Example:

If a road segment changes names along its course, every effort was made to list all names for that road segment you will travel on, in the order you will encounter them and a possible land-mark where the change takes place. The land-mark will be in the 'Travel Information' column. **Example:**

Every effort is made to inform you what town you are entering along the bike route. On the description page, town line crossings are listed in the 'Travel Information' column. **Example:**

Cautions and very important information are highlighted in red.



We recommend you carry a detailed map of the area with you.


