1. <u>RECEIPT OF BIDS</u>

2. <u>PROJECT</u>

This project generally consists of grading and shimming of an existing 28,000SF gravel parking lot as well as entrances and exits from the town road, and permanent signage. Also includes coordination with Fox Islands Electric Cooperative, who will provide and install site lighting as shown on the Drawings. Also includes the replacement of the existing manual and hydraulic wharf hoists with new hoists, as well as a new electrical service for the hydraulic wharf hoist. Additionally, the scope of work includes providing a new oil spill boom storage building, a new 4' x 30' float gangway, and general earthwork, surface restoration, erosion control, traffic control, and other Work as Specified or appurtenant.
