In the Bid Book (page 1), NOTICE TO CONTRACTORS, **CHANGE** the prices for Full and Half size plans to read as follows; "Full size plans \$109.00 (\$116.00 by mail). Half size plans \$55.00 (\$58.50 by mail),". Make this change in pen and ink.

In the Bid Book, after page 81, **ADD** the attached "SPECIAL PROVISIONS, SECTION 621 – LANDSCAPE", 1 page dated March 25, 2010.

The following questions have been received:

Question: Please provide a plant list for the following items;

Item 621.031 – Evergreen Trees Item 621.038 – Evergreen Trees Item 621.267 – Deciduous Tree

I could not find the list in the electronic bid book.

Response: Please see the attached Special Provision.

Question: Gen. Note 13 states Residential paved drives shall be constructed with 12" aggregate subbase course gravel, yet there is no 304.10 in the estimated quantities. Should this item be added or is the intent to use aggregate base course type B?

Response: The intent is to use aggregate base course type B.

Question: Gen. Note 43: Wood to be property of landowner – Is tree length acceptable?

Response: Tree length is not acceptable. Wood is to be cut into manageable lengths.

(Plant Species Specification and Quantities List)

The following list of items provides the estimated quantities for use on this project. The scientific name of the plant material is provided along with the common name in parenthesis.

The contractor shall follow MaineDOT Standard Specifications for landscape materials and installation procedures (Section 621).

The MaineDOT Landscape Architect or his designee will be available to inspect plant materials and stake the location of plant materials at the time of planting. Plantings shall occur at residences over the entire length of the project as directed by the MaineDOT landscape architect.

Establishment Period shall be incidental to Section 621 landscape items.
