1. Under column "P", **DELETE** "\$400".

SECTION 618.143
LANDSCAPE
(Method #1 Bluegrass Seed Mix)

- 45 % Creeping Red Fescue (*Festuca rubra*)
- 25 % Kentucky Bluegrass (*Poa pratensis*)
- 15 % Chewing's Fescue (*Festuca rubra commutata*)
- 10 % Perennial Ryegrass (*Lolium perenne*)
- 5% Annual Ryegrass (*Lolium multiflorum*)

Seed shall be installed according to Standard Specifications and Revisions Section 618.

This mix shall be applied at the rate of 4 lb per unit (1,000 sq. ft.)

717.03 Seed All seed shall be certified as to mixture, germination, purity, and live seed.

- A. Percent germination > 80 %
- B. Pure live seed > 85 %
- C. Percent Purity > 85 %
- D. Weed seed <1 %
- E. All seed shall be from the current years crop unless recent tests by an approved testing agency demonstrate the approved requirements.

618.12 Basis of Payment The Department will pay for the accepted quantities of seeding at the Contract price per Unit for the method specified, which price shall be full compensation for furnishing and spreading seed, limestone, fertilizer, and inoculant. The price shall also include any reseeding, watering, and maintenance necessary to meet the requirements of Section 618.10, Maintenance and Acceptance.
