Sealed Bids addressed to the Maine Department of Transportation, Augusta, Maine 04333 and endorsed on the wrapper **Maintenance Surface Treatment Paving** in the towns of **Unity, Winterport, Searsport, Swanville, Stockton Springs, Liberty, Montville, Troy, Brooks, Knox** will be received from contractors at the Reception Desk, Maine DOT Building, Child Street, Augusta, Maine, until 11:00 o'clock A.M. (prevailing time) on **April 14, 2010** and at that time and place publicly opened and read. Bids will be accepted from all bidders. The lowest responsive bidder must have completed, or successfully complete, a Highway Construction or Paving Project or project specific prequalification to be considered for the award of this contract. **We now accept electronic bids for those bid packages posted on the bidx.com website. Electronic bids do not have to be accompanied by paper bids. Please note: the Department will accept a facsimile of the bid bond; however, the original bid bond must then be received at the MDOT Contract Section within 72 hours of the bid opening.** Until further notice, dual bids (one paper, one electronic) will be accepted, with the paper copy taking precedence.

Location: In Waldo County, project is located

- Map ID 1 is in Unity - Rte 139, From the jct of Rte 220 westerly, to the jct of Rte 9.
- Map ID 2 is in Winterport, Monroe, Brooks - Rte 139, From 3.75 mi w/o the jct of Rte 69 westerly, to the intersection of Route 7.
- Map ID 3 is in Swanville, Searsport - Eastside\North Searsport Rds, From the jct of Rte 141 easterly, to the jct of Mt Ephraim Rd.
- Map ID 4 is in Stockton Springs - Main St, From the easterly jct of Rte 1 extending northerly, to the jct of Rte 1.
- Map ID 5 is in Stockton Springs - Cape Jellison Rd, From the jct of Main St southerly, to the end of designation.
- Map ID 6 is in Liberty, Montville, Knox - Rte 220, From the jct of Rte 3 northerly, to the jct of Rte 137.
- Map ID 7 is in Troy - Rte 220, From the jct of Rte 9 northerly, to the Detroit T/L.
- Map ID 8 is in Brooks, Knox - Rte 139, Beginning at the intersection of rte 137/7 in Brooks extending northerly to, the junction of Rte 139/220
- Map ID 9 is in Searsport, Frankfort - Mt Ephraim\No Searsport Rds, From 7.03 miles N/O the intersection of Rte 1, to the jct of the loggin Rd..

They also may be purchased by telephone at (207) 624-3536 between the hours of 8:00 a.m. to 4:30 p.m. Bid Book \$10 (\$13 by mail) payment in advance, all non-refundable.


Each Bid must be made upon blank forms provided by the Department and must be accompanied by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of **\$40,000** payable to Treasurer, State of Maine as a Bid guarantee. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the amount of 100 percent of the Contract price, will be required of the successful Bidder.


This Contract is subject to all applicable State Laws.
