Bids for the work shall be submitted on the "Bid" form included with the contract documents.

A 5% Bid Bond must be submitted with the Bid. The Performance and Payment Bonds shall be obtained prior to the execution of the Agreement and shall be a condition precedent to the execution of the Agreement.
