**Bids will be accepted from all bidders. The lowest responsive bidder must have completed or successfully complete a Highway, Bridge, or project specific prequalification to be considered for the award of this contract.**

Description: STP-1760(200)X STATE WIN: 17602.00.

Location: In Waldo County, the project is located along the waterfront in downtown Belfast along and adjacent to Front Street, running from Armistice Bridge to Steamboat Landing.

Outline of Work: construction of shared-use path, base, pavement, drainage, lighting, timber boardwalk, retaining walls, and other incidental work.

**The basis of the award will be on the base bid.**

A non-mandatory pre-bid meeting will be held at the City Council Chambers at 131 Church Street on Monday, January 14, 2013 at 1:00 PM.

Plans, specifications, and bid forms may be seen at the Department of Code & Planning office on the 2<sup>nd</sup> floor of Belfast City Hall. They may be viewed and picked up between the hours of 8:00 a.m. to 4:30 p.m. The documents can be purchase by cash, credit card (Visa/Mastercard/AMEX plus 2.5% handling charge with payment using any one of these cards) or check payable to City of Belfast. Full size plans: \$360 (\$400 by mail), non-refundable. Half size plans and Bid Book are available at \$25 each.
