

Roadside Mower

This work consists of furnishing and operating equipment as needed by the MaineDOT.

Equipment:

- Tractor shall be a minimum of 50 HP with ROHPS, cab with glass.
- Must have 1 360 degrees high intensity rotating or strobe light visibility (minimum 1,000,000. candle power)
- Must have slow moving triangle mounted and plainly visible.
- Must provide a minimum grass cut of 6 feet wide, mower is to be a right side off set to the tractor as traveling with traffic.
- Two types of mowers are allowed; Flail type or Disc type mowers. The Department reserves the right to consider alternates and determine equivalency. All equipment is subject to the Department's approval prior to award of the contract. Mower must be equipped with shields or flaps around cutting devices.

<u>Signs:</u> Two mowing ahead signs that meet the MUTCD standards, and while mowing, will be placed according to traffic control specs, on sides of shoulder where mowing is being performed.

Measurement and Payment: Equipment rental will be measured by the hour to the nearest ¼ hour. Time spent moving to and from the site, servicing and maintaining will not be measured for payment. Equipment rental will be measured for payment beginning no earlier than the show up time directed by the Maine DOT and end when equipment rental contract work is done for the day. The accepted quantities of equipment hours will be paid for at the contract unit price per hour, with no additional payment for overtime.

<u>Schedule</u> The Contactor shall provide and operate the equipment intermittently, as needed by the MaineDOT. The MaineDOT will notify the Contractor at least 24 hours prior to scheduled contract work.

Measurement and Payment Equipment rental will be measured by the hour to the nearest ¼ hour. Time spent moving to and from the site, servicing and maintaining will not be measured for payment. Equipment rental will be measured for payment beginning no earlier than the show up time directed by the MaineDOT and end when equipment rental contract work is done for the day. If scheduled equipment rental contract work is not cancelled prior to 5 pm on the preceding day, the MaineDOT may pay the Contractor for 2 hours for showing up. The accepted quantities of equipment hours will be paid for at the contract unit price per hour, with no additional payment for overtime.

<u>Bidding</u> As a minimum. Award and Contracting After Bid Opening and as a condition for Award of a Contract, the Department may require an Apparent Successful Bidder to demonstrate to the Department's satisfaction that the Bidder is responsible and qualified to perform the Work and that the equipment is acceptable to the MaineDOT.

The properly completed and signed Private Equipment Rental – With an Operator form provided with the Bid constitutes the Bidder's offer. Once the department has received any other pre-award items required, the Department will sign the Private Equipment Rental – With an Operator form and execute the Contract.
