JOB DESCRIPTION:

Responsible for work in the safe and efficient operation of various types of trucks and other motor vehicles used in the routine preparation of ground surfaces and roads to support a maintenance/construction project/program.

Will perform related Highway Worker - Truck Driver duties as listed on the job description.

Knowledge of standards for application of salt and sand to roads.

Ability to function as alternative equipment operator as required.

Ability to become a certified snow fighter.

Ability to visually and audibly detect possible vehicle breakdown/failure.

Be able to prepare neat and accurate equipment operating reports.

Have the ability to follow instructions.

Be able to work with other employees

NECESSARY SPECIAL REQUIREMENTS:

Pass State paid Medical examination that includes a drug test and the Department's driver examination and road test for the assigned equipment.

Be willing to work any hours or any time, and any day, including holidays, as required, as driver, operator, or at manual labor as required

Live within a reasonable distance from winter headquarters.
