## **I. SUMMARY**

Through this Order, we set the energy component and resulting standard offer energy price<sup>1</sup> for the large non-residential classes in the service territory of Central Maine Power Company (CMP) for January 2016. The energy component is \$0.03670/kWh and the resulting standard offer energy price for January 2016 will be \$0.047217/kWh for the CMP large class. The standard offer price will include this energy price plus the capacity component as specified in the November 17, 2015 Order. The specified capacity component for January 2016 is \$4.84/kW-month for the CMP large class.

## **II. BACKGROUND**

On November 17, 2015, the Commission issued an Order Designating the Standard Offer Provider for the CMP Large Class for the twelve month term beginning January 1, 2016 and ending December 31, 2016. The November 17 Order specified that the actual energy price for CMP's large customer class will be determined prior to each month of the January-December term based on ISO-NE Internal Hub Peak and Off-Peak Locational Marginal Pricing (LMP) electricity futures as settled through CME Group on the 15th day of the prior month.<sup>2</sup>

<sup>2</sup> The Commission delegated to the Director of Electricity & Gas Utility Industries the authority to determine the energy prices each month pursuant to the pricing methodology specified in the November 17, 2015 Order.

**III. DECISION**

Based on the methodology adopted in the Commission's November 17, 2015 Order, the following standard offer energy price<sup>3</sup> for January 2016 is established for the CMP large non-residential classes:

CMP--\$0.047217/kWh

As specified in the November 17, 2015 Order, the capacity component for January 2016 is:

CMP--\$4.84/kW-mo

<sup>3</sup> In this Order, the "energy" prices refer to all components of the price that are billed on a kWh basis, including line losses and the adders.

## NOTICE OF RIGHTS TO REVIEW OR APPEAL

5 M.R.S. § 9061 requires the Public Utilities Commission to give each party to an adjudicatory proceeding written notice of the party's rights to review or appeal of its decision made at the conclusion of the adjudicatory proceeding. The methods of review or appeal of PUC decisions at the conclusion of an adjudicatory proceeding are as follows:

1. Reconsideration of the Commission's Order may be requested under Section 11(D) of the Commission's Rules of Practice and Procedure (65-407 C.M.R. 110) within **20** days of the date of the Order by filing a petition with the Commission stating the grounds upon which reconsideration is sought. Any petition not granted within **20** days from the date of filing is denied.
2. Appeal of a final decision of the Commission may be taken to the Law Court by filing, within **21** days of the date of the Order, a Notice of Appeal with the Administrative Director of the Commission, pursuant to 35-A M.R.S. § 1320(1)-(4) and the Maine Rules of Appellate Procedure.
3. Additional court review of constitutional issues or issues involving the justness or reasonableness of rates may be had by the filing of an appeal with the Law Court, pursuant to 35-A M.R.S. § 1320(5).
