HOW TO OBTAIN LISTED PUBLICATIONS

Requests for copies of listed publications should be directed to the issuing state agency. Ask for the publication by name and indicate its publication date. **DO NOT USE THE CLASSIFICATION NUMBER**, as this has no meaning to the agencies; this number was assigned by the Maine State Library for its own cataloging purposes.

Inclusion of a title in this list does not guarantee, however, that the agency has copies for general distribution. Also, some state agencies may charge a fee for their publications.

Increasingly, the Checklist will list documents with an URL (Internet address). These documents are in the Maine State Library but **WERE NOT** distributed to the depository libraries. Please use the URL to locate these specific documents on the Web, and then print to obtain a paper copy.

ACCESS VIA DEPOSITORY LIBRARIES

All publications listed in the Checklist are available for use or loan at the Maine State Library and many are available for use at the following depository libraries for Maine State Publications: Bates College, Bowdoin College, Colby College, Maine State Law and Legislative Reference Library, Portland Public Library, Universities of Maine at Farmington, Fort Kent, Machias, Orono, Presque Isle, and Southern Maine - Portland Campus.

With few exceptions, these items can be found cataloged in URSUS and the MARC records of these publications can be found in OCLC.

A double asterisk (**) in front of the title indicates that only the Maine State Library received copies of this title. A triple asterisk (***) in front of the title indicates that the publication is only available online
