DO NOT USE THE CLASSIFICATION NUMBER, as this has no meaning to the agencies; this number was assigned by the Maine state Library for its own cataloging purposes.

Inclusion of a title in this list does not guarantee, however, that the agency has copies for general distribution. Also, some state agencies may charge a fee for their publications.

Increasingly, the Checklist will list documents with an URL (Internet address). These documents are in the Maine State Library but WERE NOT distributed to the depository libraries. Please use the URL to locate these specific documents on the Web, and then print to obtain a paper copy.

All publications listed in the Checklist are available for use or loan at the Maine State Library and many are available for use at the following depository libraries for Maine State Publications:
