HARVARD PILGRIM'S MOTION
FOR LEAVE TO FILE
SUPPLEMENTAL CLOSING
STATEMENT

Harvard Pilgrim Health Care, Inc. (“Harvard Pilgrim”) hereby moves for leave to file its Supplemental Closing Statement (filed today) and for its inclusion as part of the record upon which the Superintendent will render a decision on Harvard Pilgrim’s proposed rates for 2017. Harvard Pilgrim’s rate development, prefiled testimony, hearing responses and initial Closing Statement were based on four carriers participating on the exchange in 2017 and with rates among the carriers that without any one carrier gaining a disproportionate share of CHO’s likely transitioning enrollment.

Following Harvard Pilgrim’s filings and the closing of the record in this proceeding, Aetna announced on August 2 that it will not expand its participation on the exchange in 2017. Harvard Pilgrim has since learned that Aetna’s position extends to Maine and that Aetna will not participate on the exchange in Maine in 2017. As set forth in the Supplemental Closing Statement, this is a significant change that materially affects Harvard Pilgrim’s rate filing and should be considered in the review of Harvard Pilgrim’s rate filing.

For the reasons set forth above and in Harvard Pilgrim’s Supplemental Closing Statement, Harvard Pilgrim respectfully requests that the Superintendent grant leave for Harvard Pilgrim to file the Supplemental Closing Statement and include it as part of the record upon which the Superintendent will render a decision on Harvard Pilgrim’s 2017 rate filing.
