

**MAINE REAL ESTATE COMMISSION

Maine licensees renewing an active real estate license are required to complete a total of 21 clock hours of approved continuing education prior to renewal of the license. The hours must include 3 hours for the core requirement. Please note that the date your license is due for renewal determines which core course you are required to complete.
