State law assigns four core duties to the State Planning Office that include: 1) conducting continuing economic analysis, including economic forecasting, 2) coordinating the development of the State's economy and energy resources with the conservation of its natural resources; 3) providing technical assistance to towns and regions; and 4) providing technical assistance to the Governor and Legislature by undertaking special studies and plans and preparing policy alternatives.

The Hanover Comprehensive Planning Committee along with the Androscoggin Valley Council of Governments are to be congratulated for their excellent job crafting the community's new comprehensive plan. COMMUNITY ASSISTANCE PROGRAMS

Floodplain staff visits Newburgh. On September 10, Brigitte Ndikum-Nyada, Floodplain Planner, Jim Bruni and Wally Smith, Disaster Assistance Employees from FEMA Joint Field Office in Augusta, traveled to Newburgh to conduct a community assistance visit, a prerequisite to rejoining the National Flood Insurance Program (NFIP) after suspension. The Town of Newburgh has expressed interest to rejoin the NFIP. This visit provided an opportunity to talk with local officials about the NFIP and to assist the community with entry requirements. During this visit, Brigitte, Jim and Wally toured the floodplains to make sure all the structures in Special Flood Hazard Areas (SFHAs) were compliant. SPO staffer to chair work group. Joe Young, SPO's floodplain map coordinator, has been asked to chair the Geo-Library Board's geo-spatial work group. The work group is a result of the board's overall strategic planning process and is integral to its effort to provide the services mandated by the Legislature. The work group's tasks are: to review and update data standards for land use, land cover, ortho photography, high resolution topography, parcel mapping and to develop a plan, including funding sources, for data acquisition. This work will be done by calling upon the expertise of a wide variety of stakeholders across the state. Representatives from the private sector, non-profits, and state and local agencies will be involved. GOVERNOR'S OFFICE OF ENERGY INDEPENDENCE AND SECURITY

Heating Oil Average Steady. The Governor's Office of Energy Independence and Security (OEIS) conducted its off season oil survey and has found that the current statewide average cash price for No. 2 heating oil to be at **\$2.37 per gallon** unchanged from last week's survey. Within the OEIS sample, the lowest actual heating oil price of \$1.99 per gallon was found in the Southwestern region. The high-end price of \$2.70 per gallon was found in the Eastern region. The statewide kerosene price average is \$2.78 per gallon at this time.
