PARTIES

1. This is a Consent Agreement regarding the license of Timothy York to work as a plumber within the State of Maine. The parties to this Consent Agreement are Timothy York("the licensee"); the Plumbers' Examining Board ("the Board"); and the Maine Department of Attorney General ("the Attorney General"). This Consent Agreement is entered into pursuant to 10 MRSA §8003(5)(A-1) and (B).

FACTS

- 2. On May 21, 2002, Timothy York applied for a license to the Board.
- 3. Timothy York willfully failed to disclose on the application that he was convicted of the following crime(s):
 - 07/13/92 Disorderly Conduct
 - 04/10/95 Theft of Unauthorized Taking
 - 03/25/93 Theft of Services
 - 09/03/96 Assault
- 4. On the strength of this application, license #TR-90010479 was issued to Timothy York.
- 5. This license is in effect today, and Timothy York is a licensee of the board.

VIOLATION

- 6. Title 32 MRSA §3404(1) provides in relevant part that "the board may refuse to issue or renew a license or the District Court may suspend, revoke or refuse to renew the license of any licensed plumber for...the practice of any fraud or deceit in obtaining a license."
- 7. The licensee admits that his non-disclosure of the above-mentioned conviction on the application dated May 21, 2002 constituted the practice of fraud or deceit in obtaining a license in violation of 32 MRSA §3404(1).

9. As discipline for this violation, the licensee shall pay a civil penalty of \$250.00 upon signature of this Consent Agreement.

MISCELLANEOUS


10. This Consent Agreement is not appealable and remains in effect until modified or rescinded in writing by the parties.

11. The Board and the Attorney General may communicate and cooperate regarding any matter relating to this Consent Agreement.

12. This Consent Agreement is a public record as defined in 1 MRSA §402 and is available for inspection and copying by the public pursuant to 1 MRSA §408.




