PARTIES

1. This is a Consent Agreement regarding the license of Michael Cogswell to work as a plumber within the State of Maine. The parties to this Consent Agreement are Michael Cogswell ("the licensee"); the Plumbers' Examining Board ("the Board"); and the Maine Department of Attorney General ("the Attorney General"). This Consent Agreement is entered into pursuant to 10 MRSA §8003(5)(B).

FACTS

- 2. On February 22, 2008, Michael Cogswell applied for a license to the Board.
- 3. Michael Cogswell willfully failed to fully disclose on the application that he was convicted of the following crime(s):

Class D, Operating Under the Influence on 1/9/01

VIOLATION

4. Title 10 M.R.S.A. §8003(5-A)(A)(1) provides in relevant part that "the board may deny or refuse to renew a license ...for ... the practice of fraud, deceit or misrepresentation in obtaining a license from the board ... or in connection with services rendered while engaged in the occupation or profession for which the person is licensed." For the reasons set forth, the board believes that you failed to disclose a criminal conviction(s) on a license application, and that this nondisclosure constitutes the practice of fraud or deceit in obtaining a license in violation of 10 M.R.S.A. §8003(5-A)(A)(1).

5. The licensee admits that his non-disclosure of the above-mentioned conviction on the application dated February 22, 2008 constituted the practice of fraud or deceit in obtaining a license in violation of 10 MRSA §8003(5-A)(A)(1).

6. As discipline for this violation, the licensee shall pay a civil penalty of \$50.00 no later than March 31, 2008.

7. If the licensee fails to pay this amount in full by the due date, the licensee understands that a license will not be issued.

MISCELLANEOUS


8. This Consent Agreement is not appealable and remains in effect until modified or rescinded in writing by the parties.

9. The Board and the Attorney General may communicate and cooperate regarding any matter relating to this Consent Agreement.


10. This Consent Agreement is a public record as defined in 1 MRSA §402 and is available for inspection and copying by the public pursuant to 1 MRSA §408.


