ALERT: DO NOT Use Leading "1" in Telephone Numbers on Workers' Compensation Board Forms

Many claim administrators are using eleven-digit phone numbers (i.e.: 1-800- XXX-XXXX) on MWCB forms. EDI only allows 10 characters for phone numbers; therefore, the last digit of each eleven-digit phone number is being cut off. This makes it very difficult for the Board's Troubleshooters and other Dispute Resolution staff to contact injured employees, claim adjusters, etc.

Claims at "Max"

While there are no cost-of-living adjustments for post **12-31-92** dates of injury, claims being paid at the maximum weekly benefit level (maximum rate) are subject to an inflation adjustment or escalation on or about **7-1** of each year.

The Board is tracking claims subject to the maximum rate to ensure that injured employees are being paid at the correct rate and to ensure that WCB-4 forms are filed to document any changes in the weekly compensation rate.

Information regarding annual cost-of-living adjustments (pre 1-1-1993 dates of injury) and inflation adjustments (post 12-31-92 dates of injury) can be found on the Board's website at:

Reminder: failure to pay accrued weekly benefits within 30 days after becoming due and payable is subject to penalty under Section 205(3).

Do Your Compliance Percentages Look Low this Quarter?

A little checking may go a long way to improving your compliance. Remember that the second quarter of 2008 had a State holiday (Patriots Day) on Monday, April 21 even though this may have been a work day for you. Also, mail did not move on Monday, May 26 (Memorial Day). Unless you sent your MOPs electronically (the fax machine is always on and the server date stamps e-mail even when no one is here), these holidays may have adversely affected your compliance scores for this form.

If your MOP compliance scores were adversely affected by one or both of these holidays, please note that you can submit a rebuttal along with your reconciliation report response.
