- > The Aroostook Shared Community Engagement Committee has been planning the Aroostook Shared CHNA forum for Wednesday, November 3, 2021.
- ➤ The State Public Health Systems assessment was completed in August. Results are expected by the end of the year.

#### **Progress with District Public Health Improvement Plan:**

- > The Emergency Planning Committee continues to provide space for partners to discuss COVID-19 Vaccinations efforts throughout all of Aroostook County. Houlton Regional Hospital leadership shared a letter send from the Doctors and Administration to unvaccinated staff encouraging staff to get vaccinated. They shared it as an example for other hospitals would if they wanted to put out their own.
- ➤ The Homebound Vaccination Workgroup has on-going collaborations happening weekly. This workgroup has administered 115 120 vaccines.
- > The COVID-19 Messaging Workgroup has come out with a "DON'T Wait, Vaccinate!" campaign is on to the second phase of their campaign working with the Youth Testimonials which will be for Radio, TV, Print & Social Media
- ➤ The Healthy Aging Committee is hosting monthly drop-in RoundTable meeting to facilitate any Healthy Aging related barriers or supports needed by partners.

http://www.maine.gov/dhhs/boh/olph/lphd/index.shtml The July quarterly DCC meeting focused on Maine's *Connecting with Opportunities Initiative* with Doug Dunbar, the Recovery and Re-entry Workforce Specialist at EMDC (Eastern Maine Development Corporation). Doug spoke about the available workforce development programs, the services they offer, and how they're changing lives. We discussed outreach opportunities and how to make referrals, and then had updates and collaboration asks from the group.

The Steering Committee had COVID-19 Situational Awareness updates on pandemic response, assisted with vaccination outreach, and has continued to review 211 call and unmet needs data to help ensure that district resources are included in 211 and people are getting connected to the help they need.

Ongoing or upcoming projects or priority issues: COVID-19 response, infection prevention, PPE and testing supplies provision; vaccination clinic, appointment, and transportation assistance; assistance for organizations providing basic needs and connecting people to those resources. Limited work on the Partners for Recovery (PFR/HRSA) Grant and hospital HRSA grants; Harm Reduction/ Needle Exchange capacity building and Naloxone distribution; and ACEs-Resilience training and resources. Shared CHNA Community Engagement Forum dates set for November 16 and 18; browntail moth info and training.

**Progress with District Public Health Improvement Plan (DPHIP):** *Activities planned for completion during the quarter and whether activities are able to be completed on schedule* 

- ▶ Use Central District Public Health Unit updates to communicate important information to DCC, LHOs, chief municipal officials, and partners. Ongoing task.
- ▶ Workgroups have been less active this quarter to deal with COVID-19 pandemic response and infection prevention working conditions.

#### Successes achieved

▶ The ACEs-Resilience Workgroup has met bi-monthly to share toolkits, training opportunities, and resources; and to advise the MaineGeneral HRSA Substance Use Prevention grants. Members are working on school and community supports for trauma and pandemic recovery.

#### Barriers encountered

▶ Disruption in usual way of doing business and lack of staff time for other DCC tasks due to COVID-19 pandemic response.

**Structural and Operational changes, including updates in membership**: Filled vacant MaineGeneral Steering Committee member position.

**In-district or multi-district collaborations:** COVID-19 response with County EMAs and regional EMS; prevention/basic needs assistance for organizations serving vulnerable populations (e.g., shelters, long term care, congregate living, behavioral health providers, at-risk youth programs, food/meals programs, libraries, schools); COVID-19 vaccination information and assistance; transportation assistance; town vaccination clinics; HRSA grants and regional assessment; browntail moth information and workshops.

**Other topics of interest for SCC members:** Greatest need right now is for partner assistance with mainstreaming infection control practices and combatting vaccination hesitancy.

#### **DCC Meeting 6/25/2021**

Introductions and Deepening Connections: Jamie welcomed participants and opened the floor for introductions.

Participant Check-In: Safe Voices shared their upcoming opportunities for connecting and outreach. They have a resource center with direct services. Their free, confidential, and anonymous 24-hour helpline is: 1-800-559-2927.

Healthy Androscoggin is starting to shift from Covid-19 vaccination efforts. They are now starting to focus on regaining normalcy including work around the Shared Community Health Needs Assessment (CHNA) planning process and vaccine hesitancy.

Healthcare Coalition of Maine is a state-wide coalition. More information can be found at: https://www.mainehccs.com/ Will be scheduling in-person meetings for the future.

WIC is happy to share that many participants are enjoying the new EBT Cards instead of the former paper checks. Paper checks are still used for the Farmer's Market program. There is an increased amount of funds on the cards of \$35/person for fruits and vegetables for the time being.

Healthy Oxford Hills has hired Hollie as their new Director, and they are hiring a new SNAP-Ed. Healthy Oxford Hills is also starting the Shared CHNA process. They are supporting a hospital food pantry 5 days/week – starting with client/patient-only access and planning to move public. Also discussed a MaineHealth/Statewide initiative to train providers with the necessary skills to address behavioral health needs of patients.

Community Concepts has finished their work with the emergency/Covid-19 shelter, and that is now being supported by Preble Street. Discussed their ongoing efforts around social determinants of health, retroactive rent relief and mortgage relief. They were awarded grant funding to support 190 new safe housing units. Community Concepts is hiring with a focus on employing those in marginalized communities. Highlighted the importance of the Alternative Response Program: https://www.ccimaine.org/child-welfare

River Valley Healthy Communities Coalition identified a gap in food access as a local church had closed. They are organizing a food pantry and are starting outreach for community feedback regarding days and times for the pantry.

Healthy Community Coalition of Greater Franklin County is starting to get back to their normal work as they have transitioned from vaccine clinics 5 days/week down to 1 day/week. The Mobile Health Unit is back, and they will have a food pantry next to HCC. They are also focusing on Narcan/Naloxone distribution and education.



Androscoggin Home Healthcare and Hospice is supporting homebound individuals with wellness checks and Covid-19 vaccines.

Public Health Nursing is supporting home visits as well as hosting pop-up clinics with both Pfizer and Johnson and Johnson vaccines. School-aged childhood vaccination catch-up clinics are being offered during the summer and PHN is highlighting the importance of establishing primary care providers for those without one. ### **District Coordinating Council Update**

#### 22 M.R.S.§412 (2011).

- A. A district coordinating council for public health shall:
- (1) Participate as appropriate in district-level activities to help ensure the state public health system in each district is ready and maintained for accreditation; and
- (4) Ensure that the essential public health services and resources are provided for in each district in the most efficient, effective and evidence based manner possible.
- A-1. The tribal district coordinating council shall:
- (1) Participate as appropriate in department district-level activities to help ensure the tribal public health system in the tribal district is ready and maintained for tribal public health accreditation; and
- (2) Ensure that the national goals and strategies for health in tribal lands and the tribal district health goals and strategies are aligned and that tribal district health goals and strategies are appropriately tailored for each tribal health department or health clinic
