Staff Recommendation, requests for Intervenor status pertaining to Zoning Petition ZP 707 to SUBJECT: implement a proposed Concept Plan in the Moosehead Lake Region (Plum Creek Maine Timberlands, L.L.C., and Plum Creek Land Company).

Background

On April 27, 2007, Plum Creek Maine Timberlands, L.L.C. and Plum Creek Land Company (Plum Creek) submitted to the Land Use Regulation Commission an amended Petition for Rezoning to implement a concept plan on its ownership in the Moosehead Lake region. LURC staff conditionally accepted for processing the amended Petition on May 18, 2007, and the Chair of the Commission concurrently set a deadline of June 20, 2007 for filing with LURC petitions to intervene by interested parties.

Review Criteria

Pursuant to Section 5.13(1) ("Petition for Intervention") of the Commission's <u>Rules for the Conduct of Public Hearings</u>, prior to the commencement of any public hearing of the type described in Section 5.16(1) of these regulations, the Commission may require or allow any person who desires to participate as a party, offer testimony and evidence, and participate in oral cross-examination to file a petition under oath or affirmation for leave to intervene. Notice of the requirement of filing a petition of intervention shall be given in a manner consistent with Section 4.04(7) of these regulations or in such other manner as the Presiding Officer deems appropriate. A petition to intervene shall be granted if it demonstrates that the petitioner is or may be substantially and directly affected by the proceeding.

The Commission may further allow any other interested person to intervene as a party or to participate in more limited manner as the Commission or its Presiding Officer may designate.

A petition for leave to intervene must be filed by the date specified by the Commission or the Presiding Officer or, if an earlier date is not specified, by the date of the public hearing. A petition to intervene which is not timely filed will be denied unless the petitioner shows good cause for failure to file on time. A person permitted to intervene shall become a party to the proceeding and shall be permitted to participate in all phases of the hearing, subject, however, to such limitations as the Commission or Presiding Officer may direct. Petitioners

may be required to consolidate or join their appearances in part or in whole if their interests or contentions are found to be substantially similar and such consolidation would expedite or simplify the hearing without prejudice to the rights of any party or petitioner. A consolidation under this section may be for all purposes of the proceeding, all of the issues of the proceeding or with respect to any one or more issues or purposes thereof.

- Pursuant to Section 5.14 ("Participation by Interested Persons") of the Commission's <u>Rules for the Conduct of</u> <u>Public Hearings</u>, any person may, in the discretion of the Presiding Officer, be permitted to make oral or written statements on the issues, introduce documentary, photographic and real evidence, attend and participate in conferences and submit written or oral questions of other participants, within such limits and on such terms and conditions as may be fixed by the Commission or the Presiding Officer.
- 3. Pursuant to Section 5.15 ("Governmental Agencies") of the Commission's <u>Rules for the Conduct of Public Hearings</u>, governmental agencies may notify the Commission of their anticipated participation in any hearing in the form and manner required by Section 5.13(1). Such governmental agencies shall, upon having filed such notice, be entitled to all rights of an Intervenor in such proceedings. Representatives of governmental agencies may participate in their official capacity only if representing the views of the agency on whose behalf they appear, and not personal views and opinions. Governmental agencies may still provide testimony at the hearing without filing a notice under this section.

Staff Recommendation

Based on the petitions submitted by the parties requesting Intervenor status, the staff concludes that all parties have demonstrated that the parties are or may be substantially and directly affected by the proceeding for Zoning Petition ZP 707, in accordance with Section 5.13 of the Commission's Rules. Staff, therefore, recommends that the Commission:

- (1) Conditionally approve the petitions to intervene in the proceeding for Zoning Petition ZP 707 for all 32 parties requesting such status, subject to paragraph (2), below; and
- (2) Delegate to the Chair of the Commission the authority to make final determinations as to:
 - a. which of the 32 petitioning parties should be approved for full intervenor status, and which should be approved for Interested Person status, pursuant to Section 5.14 of the Commission's rules; and
 - b. consolidation of Intervenors and/or Interested Persons into groupings pursuant to Section 5.13 of the Commission's Rules.
