Thank you again for holding the public hearing on August 13<sup>th</sup> in Princeton concerning the proposed cell tower in Big Lake Township. We appreciate the process. We just would like to make a few comments concerning the testimony that was given.

We heard a good deal of passionate pleas from the public advocating for better cell coverage in our area. We too would like better coverage. In our mind, public safety is the biggest issue but many people are just plain passionate about all forms of their social media. We believe many citizens at the hearing would be just as passionate against a tower being erected next door to their house. They might have more accurately testified, "I am passionate about getting better cell coverage as long as the tower isn't in my back yard."

I do not think it went unnoticed that Black Diamond Consultants did not do a thorough job at documenting the visual impact of the tower. We are so glad the commissioners made a site visit. As was mentioned at the hearing, Black Diamond has never contacted us, the neighbors next door. You did not see any pictures of our house in their photo presentation. We are not hard to find. We live right here and our name is on the tree farm sign out front. Why would they take a picture of the front of the church in Princeton 5 miles away but not our house located next to the project? We would have invited them on our property. However, they could have parked on the road in front of our house and taken a picture of the balloon in the background. In fact we believe they could have taken pictures from the yards of any of our neighbors if they had only asked. To our knowledge they only asked permission to enter one neighbor's property and it was granted to them. One picture was taken from the road from behind a neighbor's hedge row of trees. It was also obvious their report was lacking because no documentation of the views from watercraft on Big Lake were considered. They took a picture of trees at a boat launch with not mention that if you shoved a boat out into the water at the landing, the tower would be right there, visible. What about all the camp owners on the opposite side of the lake? Some of their pictures really did not pass the straight face test. Pictures were shown at a distance in the direction of the balloon and because the balloon could not be easily spotted, we were told we would also not be able to see a 250 ' steel tower equipped with 6 antenna platforms and two lights. All visual assessment photos were taken with the leaves on the trees and none were taken at night. The balloon had no strobe light tied to it. No mention was made during the hearing of the potential noise made by the wind whistling through the lattice work of the steel tower.

The U S Cellular lawyer said home valuations are not affected by cell towers in New Hampshire. We doubt that assessment and we are sure home valuations would be affected in Maine. I would like to pose this question. If a family was looking to buy a country home and they found two identical homes for about the same price, but one had a 250 foot cell tower next door, which property would they most likely buy?

Since the field visit, a measurement was made from our common property line to the stake showing the location of the proposed tower. It is about 320 feet. The Cochran lot is about 1250 feet wide and quite flat. Would it not be too much to ask that the tower be located in the center of the wooded property? If in fact the center of the property is a lower elevation, I believe it would be no more than a couple feet. This would be the time to make that change. No land clearing or test borings for the tower site have been made yet. A service road and power line extending further back on the property and another 300 feet into the center of the Cochran property does not seem too much to ask for this permanent project. It would put the tower back further from the public road, lake and neighbors at only a minimal increased cost to U S Cellular. Mike Marshall and Chris Cochran spoke during the site visit. Chris said he would not be opposed to moving the location of the tower on his property.

If U S Cellular is granted a permit for a cell tower on the Cochran property please seriously consider mitigating the visual impact of the tower on the community in accordance to Chapter 10 section E. The Cochran property is made up of combined lots that total about 44 acres. The total lot is about 1250 feet wide and 1730 feet deep. Please require the tower structure to be at least 600 feet from any abutting property and further back away from the public road and lake. This would only minimally affect the project's cost but would help mitigate the visual, sound and safety impact. According to the standards of Chapter 10 section E., this proposed development should be placed in a way to minimize visual impact on the surrounding area and to least likely block or interrupt scenic views from traveled ways, water bodies and public property. Please minimize the negative impact of this development in our community. Thank you.

Hi Karen:

Jean (thank you for taking my call today!) suggested that I write you in regards to the Big Lake Township vs. US Cellular site situation.

- 1. My company, Pioneer Broadband, has fiber optic lines available which could serve the US Cellular site on West St in Big Lake Township. We built fiber there last year which was funded by a ConnectME grant, so we are always on the lookout for potential customers.
- 2. If the site is not permitted, I have a suggestion on how USC could serve the area without the "Visual Disturbance" that a 300 foot tower causes.

Specifically, if the tower were located on nearby Pocomoonshine Mtn., a much shorter tower could be used, perhaps 60 to 100'. And, if the town (Princeton, I think) is smart they would contract with to put their Public Safety radio on the tower for a reduced rate.


I know that one of the goals of this tower is to provide better service to the Town of Grand Lake Stream as well. From the Pocomoonshine site a relay could be built to send a microwave signal over to the tower on the hill at the end of Church St. Pioneer sold GLS the tower a few years ago with this sort of project in mind. Pioneer would also apply for grant funds to serve Grand Lake Stream and the US Cellular equipment as well.

I would like to submit some comments for the propsed cell tower located on Chris Cochran's property in Big Lake Twp.

First I would like to say that I completely support the tower.

It would allow myself as well as many other residents in the area to cancel my landline phone saving me personally over \$600 a year.

I know there have been some concerns or comments on the light on the tower. I feel there are some points that have not been brought up.

1. The tower is being placed on basically flat ground. Many times when towers are placed they are on a hill which in turn makes them much more visible for longer distances. This would be best illustrated by looking at Musquash Mountain in Topsfield from Big Lake. The towers are approximately 17 miles away and are visible on clear days and nights. This would not be the case in Big Lake Twp.

I spend a great deal of time on Big lake and made it a point to speak to as many people as I could about a cell tower near Jimmy Libby cove that I know have places on lake or were here visiting. I heard people make a comment about the tower bothering ecotourism because of the sight of it. I find that to be completely untrue. I did not hear one negative comment from anyone that I spoke with. The visibility of the tower in my personal opinion would be restricted to Jimmy Libby and Sand Cove. I have made it a point to look at the places that one could possibly see the tower and cannot see where it would be visible from many other locations on the lake.

- 2. A second point that has been brought up about the light is the light pollution. That is not the case. If one was out on Big Lake at night in most any part of the lake and you look back at the direction of where the proposed tower is to be located there are already two thing that have very bright lights. One is Woodland Pulp LLC lights from their facility actually make a glow in the night sky. The second light is the rotating beacon from Princeton Municipal Airport is also visible most any night.
- 3. The last point I would like to make is from a safety stand point. I own a camp in Clifford Bay on an Island on Big Lake in Big Lake Twp. I often leave my wife and two small children there while I go to work and I am constantly worried about them as cell service is not very good there and we must go out on the dock to talk. The tower would give me some security that they could call in the event of an emergency.

I feel that this tower will enhance our area as technology has become such a huge part of our lives. For people that come from away it is just as important for them to stay connected with their world while on vacation as it is for us to have reliable service as part of our everyday lives.
