Thank you for keeping me informed about the progress of this matter. I would like to add further comment.

I have reviewed public comment previously offered by others. These remarks center around the benefits that increased telecommunication capability will offer to the Rangeley region. I have no reason to question these assertions at present. However, I think these comments miss the point of the current review.

The issue at hand is not the needs and wants of the region regarding telecommunications access. The issue is where this access is to be located. I have read the previous and current proposals to locate the tower in Dallas Plantation. I hasten to add that the proposed tower is three hundred feet tall which is equivalent to the length of an entire football field.

The previous plan was rejected because the project was located too close to residential and recreational property. It appears to me that the new location is not significantly different from the last plan. The adjustments really make no significant, practical difference from the rejected site.

Dallas Plantation and the neighboring Rangeley region are obviously very large and it is very difficult for me to believe that an appropriate site cannot be found which will serve the telecommunications purpose while not disrupting the natural, residential, and recreational surroundings.

I therefore again register my strong rejection of the current plan to build the tower at the proposed site.
