Jeremy,

The Land Use Planning Commission (LUPC) has received your request to extend the deadline established in the LUPC's February 2021 letter regarding Wolfden Mt. Chase, LLC's (Wolfden's) pending rezoning petition, ZP 779. The LUPC's letter requested that additional information be filed within 60 days of the date of the letter. Wolfden has requested an extension until September 1, 2021 to file a response. Given the scope of the LUPC's request for additional information and Wolfden's stated interest in providing a comprehensive response to issues that have been raised, the LUPC herein grants the request.

Please be aware that the LUPC currently does not intend to grant any further extensions to the filing deadline for responding to its February 2021 letter. If you find additional time will be needed, we respectfully request that you withdraw the petition until all the information is ready to submit.
