***Water & Electric Hook-ups:** There are some campsites with water and electric hook-ups at Camden Hills, Peaks-Kenny and Sebago Lake State Parks. For Camden Hills and Sebago Lake, hook-up sites are \$35.00 per night for Maine residents and \$45.00 per night for non-residents. For Peaks-Kenny, hook-up sites are \$30.00 per night for Maine residents and \$40.00 per night for non-residents.

Campsite Reservation Fee - All campsite fees are per site, per night. An additional fee of \$5.00 per night, per site will be charged for reservations. Reservations cannot be made for campsites in the Allagash Wilderness Waterway or the Penobscot River Corridor.

GROUP CAMPING FEES AND EXEMPTION GUIDELINES

Group Camping Area Reservation Fee - \$50.00, nonrefundable. At those facilities where group campsites are available and where prior reservations have been made, organized groups of campers shall pay \$5.00 per person, per night. There is a minimum group camping fee of \$50.00 night.

1. State of Maine organized group programs for residents of State and Federal institutions (Dorothea Dix and Riverview Psychiatric Centers, and Togus Veteran's Administration);
2. State of Maine school/education programs during the school year (September 1 through June 30 – no application needed, contact park directly).

ALLAGASH WILDERNESS WATERWAY FEES

Residents \$6.00/per person/per night – Non-resident \$12.00/per person/per night - Children under 10 years of age – free.
Winter fee - Chamberlain Thoroughfare Bridge parking lot and the Kellogg Brook site, Residents \$75.00/month/per site, Non-residents \$100.00/month/per site.

PENOBSCOT RIVER CORRIDOR FEES

Residents \$6.00/per person/per night – Non-resident \$12.00/per person/per night - Children under 10 years of age - free

MISCELLANEOUS FEES

Boat Launching Fee – For park access, limited to parking and boat launching, the daily fee for launching trailered boats, shall be the posted per person day-use fee or \$10.00 per vehicle, whichever is less. The maximum fee for any trailered boat access shall be \$10.00 - where available.

Songo Lock - \$7.50 per boat, per passage. Boats requiring both gates open - special arrangements must be made.

Commercial Bus Tours - \$75.00/bus/trip – where available (reservations required).

Campground Visitors - Will be admitted by paying the day-use fee or by using their season passes.

Dumping Station - \$20.00 per unit (day-use customers) where permitted – where available.

All Day-Use Areas: Day-use fees are per person, per day. Maine residents 65 or over: free; Children 5 - 11 years old: \$1.00; Children under 5 are free. *Children under 12 are free at Colonial Pemaquid State Historic Site. **Children 5-11 years old at Fort Knox only \$2.00; with Observatory Tower \$4.00. Maine residents 65 and older \$2.50 at Fort Knox with Observatory.

PASSES – DAY-USE

Vehicle Pass - \$105.00 - Allows all the occupants of up to a 17-passenger vehicle to day-use.

Senior Citizen Annual Vehicle Pass (65 and over) - \$45.00 – Allows all the occupants of up to a 17-passenger vehicle to day-use (Senior Citizen must always be in the vehicle).

Individual Pass - \$55.00 - Allows ONLY the individual pass holder day-use.

Senior Citizen Pass – Effective 7/1/08, Senior Citizen Passes are no longer issued. Maine Residents age 65 and older receive free day-use. Passes issued before 12/31/91 will be honored.

Business Vehicle Pass (one-time, day-use) - sold in blocks of 25 for \$250.00 – to purchase or for more information, call 207-287-2209.

GROUP RESERVATION FEES - DAY-USE

Group Shelter Reservation Fee - \$150.00, nonrefundable, in addition to day-use fee, except at Damariscotta Lake, Ferry Beach, Swan Lake and Warren Island State Parks, which are \$100.00. In addition to the shelter fee, the Resource Room at Range Pond State Park may be reserved for a nonrefundable fee of \$150.00.

Group Site Reservation Fee - \$35.00, nonrefundable charge at Crescent Beach, Lamoine, Range Pond, Sebago Lake and Two Lights State Parks only, in addition to day-use fee.

GROUP EXEMPTION GUIDELINES - DAY-USE

Qualified exempt groups (see list below), with prior written approval or with a Group Exemption Pass, shall not be charged a fee.

1. State of Maine organized group programs for residents of State and Federal institutions (Dorothea Dix and Riverview Psychiatric Centers, and Togus Veteran's Administration);
2. State of Maine school/education programs during the school year (September 1 through June 30 – no application needed, contact park directly);
3. State of Maine organized group homes/programs for disadvantaged or persons with disabilities.
