## **1999 Interest Rate**

The Executive Director of Maine Revenue Services has established the interest rate for 1999 at 9% per annum compounded monthly. The rate is lowered a full percentage point from last year's rate.

Maine Revenue Services, Thomas College and the Internal Revenue Service are sponsoring the 1998 Maine Tax Forum to be held at the **Augusta Civic Center**, **Augusta**, **Maine** on December 2nd and 3rd.

The forum provides a rare opportunity for tax preparers and business people to talk with representatives from Maine Revenue Services and the Internal Revenue Service, including the New England District Director, Stephen L. Daige. Maine Governor Angus S. King will deliver the key note address at 10:30 a.m. on December 2. Many CPA and law firms throughout Maine will have representatives that give presentations on a wide variety of tax matters.

The program is designed to meet the annual tax educational needs of the tax return preparer and consultant, as well as business people. Two concurrent sessions will be offered on both days of the seminar. The topics to be covered range from individual income taxation to estate tax. There will be extensive coverage of Maine sales and use tax presented, which will be one day in length. **The fee is \$30 each day, which will include program materials and lunch**.
